{d})--The--Social---Services---Administration---shall---issue regulations---governing---access---to--and--use--of--confidential information-{which-is-in-the-possession-of-the-Administration--or local-departments-of-social-services} UNDER-THIS-SECTION.

{e})--Any--offense--against--the--provisions--of--this--section shall-be-a-misdemeanor-and-shall-be--punishable--by--a--fine--not exceeding--five--hundred--dollars--(\$500)--or-imprisonment-for-not exceeding-ninety-days,--or-beth,--in-the-discretion-of--the--court.
