CHARTER AMENDMENT RESOLUTION NO. 1985-1

RESOLUTION NO. 588

RESOLUTION OF THE CITY OF GREENBELT ADOPTED PURSUANT TO THE AUTHORITY OF ARTICLE 11E OF THE CONSTITUTION OF MARYLAND AND SECTION 13 OF ARTICLE 23A OF THE ANNOTATED CODE OF MARYLAND (1957 EDITION AS AMENDED), TITLE "CORPORATION-MUNICIPAL", SUBTITLE "HOME RULE", TO AMEND THE CHARTER OF THE CITY OF GREENBELT FOUND, IN WHOLE OR IN PART, IN THE COMPILATION OF MUNICIPAL CHARTERS OF MARYLAND (1983 EDITION AS AMENDED) AS PREPARED BY THE DEPARTMENT OF LEGISLATIVE REFERENCE PURSUANT TO CHARTER 77 OF THE ACTS OF THE GENERAL ASSEMBLY OF MARYLAND OF 1983, BY REPEALING AND RE-ENACTING WITH AMENDMENT SECTION 40, TITLE "PURCHASES", TO PROVIDE THAT THE COUNCIL SHALL PRESCRIBE BY ORDINANCE A COMPETITIVE BID PROCEDURE AND SHALL ESTABLISH A DOLLAR AMOUNT OF PURCHASE NOT TO EXCEED TEN THOUSAND DOLLARS (\$10,000) ABOVE WHICH THE TAKING OF COMPETITIVE BIDS SHALL BE REQUIRED SUBJECT TO EXCEPTIONS AS MAY BE PERMITTED AND SET FORTH IN THE ORDINANCE, SUCH EXCEPTIONS TO INCLUDE AWARDS OF PURCHASE BASED UPON BIDS RECEIVED FROM OTHER AGENCIES, THE PURCHASE OF SPECIAL CATEGORIES OF SUPPLIES, MATERIALS, EQUIPMENT OR CONTRACTUAL SERVICES FOR WHICH THE COUNCIL DETERMINES A COMPETITIVE BID IS NOT FEASIBLE, AND THE AUTHORIZATION FOR NEGOTIATED PURCHASE WHENEVER IT IS DETERMINED TO BE IN THE BEST INTERESTS OF THE CITY OR AN **EMERGENCY EXISTS**

RESOLUTION OF THE CITY OF GREENBELT ADOPTED PURSUANT TO THE AUTHORITY OF ARTICLE 11E OF THE CONSTITUTION OF MARYLAND AND SECTION 13 OF ARTICLE 23A OF THE ANNOTATED CODE OF MARYLAND (1957 EDITION AS AMENDED), TITLE "CORPORATION-MUNICIPAL", SUBTITLE "HOME RULE", TO AMEND THE CHARTER OF THE CITY OF GREENBELT, FOUND, IN WHOLE OR IN PART, IN THE COMPILATION OF MUNICIPAL CHARTERS OF MARYLAND (1983 EDITION AS AMENDED) AS PREPARED BY THE DEPARTMENT OF LEGISLATIVE REFERENCE PURSUANT TO CHAPTER 77 OF THE ACTS OF THE GENERAL ASSEMBLY OF MARYLAND OF 1983, BY REPEALING AND REENACTING WITH AMENDMENTS SECTION 36, TITLE "SAME-POWERS", TO PROVIDE THAT THE THIRD PARAGRAPH SHALL BE TITLED (c) APPOINTMENTS BASED ON QUALIFICATIONS; DISCRIMINATION PROHIBITED., AND TO BROADEN THE PROVISIONS OF THIS SECTION.
