ANY TAX SALES MADE OR INSTITUTED AFTER DECEMBER 31, 1943, SHALL BE MADE ONLY IN ACCORDANCE WITH THE PROVISIONS OF PARTS I THROUGH III OF THIS SUBTITLE. HOWEVER, ALL LAWS REPEALED BY THIS
