be ſet forth that he Appear before her ſaid Maj^t Justices at the next C^t to be held for
ſaid County at the Towne & Port of Chifer to Anſwer unto all Such things as shall be
then & there objected againſt him & that he haue them ſhowne the ſaid Writteⁿ

All which ſaid neare C^t vñ the twenty third day of March in the year
aſt the day of the returne of ſaid Writt came Edward Scott knight the wife of ſaid
County & made returne thereof in these words hereon endorsed vñ

And now here at this day vñ the twenty third day of March in the aſt came
the ſaid Thomas Jones in his proper person and being called appears according
to judgement

Upon motion of the aſt Thomas Jones to the Sheriff of C^t that he
might have Council affigned to him he being Ignorant in Such Caſe — Therefore
it is ordered by the C^t here that Christopher Philips & Thomas Downe be
affigned as Council for the aſt Thomas in this behalfe

The aſt Council of the aſt Thomas Jones pray the C^t that the same may
be proponed till tomorrow morning w^{ch} was not granted by reason that they could
ſhow no reaſon for y^e same but the judgement was as followeth

Kent County for the Jurors for our Sovereigne Lady the Queene that now is in the body of ſaid County upon
in Maryland their Oath doo present Thomas Jones of ſaid County Otherwise called Thomas
Jones of the same County for that he the ſaid Thomas at Mergans Geo the hundred in ſaid County
within the Jurisdiction of this C^t the year of God before his eyes not having but being deluded
and drawn by the Inuictments & corrupt Puliuation of the flesh & the Indigacion of the Deock on
the fifteenth day of Aug^{ust} anno Domⁱ One thousand and Seaven hundred & fourtyn two years tunc
as well before as since hath had the like Inuictions & been in a dallery wth a certaine Mary
Tiller the wife of John Tiller late of the same County Carpenter to the great displeasure
