And that he then & there have y^e s^t Writ^{te} &c.

At w^{ch} next Co^{rt} viz^t y^e twenty sixth day of August in y^e year a f^r y^e day of y^e returne of s^t Writ^{te} came Tho^s Smyth Cor^{on} of s^t County and made returne thereof in these words Viz^t These are to certify to y^e Justices wth in command that I have attached in y^e hands of Edw^d Scott Sheriff three hundred sixty & foure pounds of Tob^o and y^e Addition^{all} cost and made y^e same knowne before Philip Rozens & Milton two good & lawfull men of my Baywick as y^e w^{ch} in exactth requirth I am Tho^s Smyth Cor^{on}.

And now here at y^e s^t Co^{rt} viz^t this twenty seventh day of Aug^r a f^r cometh y^e s^t In^o Dowdall by Michael Parke his Atty^{ny} and moveth y^e Co^{rt} for condemnac^{on} of y^e goods & chattels of y^e a f^r In^o Gandy as a f^r Attached And y^e s^t Edw^d Scott Garnishee of y^e s^t In^o Gandy being solemnly called cometh and saith that he hath not any cause to show in barr or delay of condemnac^{on} thereof &c &c Therefore it is considered by y^e Co^{rt} here that y^e a f^r sume of three hundred sixty & foure pounds of Tob^o and y^e Addition^{all} cost being one hundred & seaventy pounds of Tob^o attached in y^e hands of y^e a f^r Edw^d Scott be condemn'd And that y^e s^t In^o Dowdall thereof have Execuc^{on} Jam^s Smith Clk
