AND the a<sup>ft</sup> John Frogett in his proper person cometh into C<sup>t</sup> and sayth that he  
cannot gainsay the Auon a<sup>ft</sup> of him the Said Nathaniel Hyuson nor but that the writ-  
ing obligatoy a<sup>ft</sup> mentioned is his Act & Deed and that he oweth to the Said Nathaniel  
the a<sup>ft</sup> Summe of Six thousand nine hundred eighty Six pounds of Tobacco: Therefore  
it is Considered by the C<sup>t</sup> here that the Said Nathaniel Hyuson doe recover against  
the Said John Frogett the a<sup>ft</sup> Summe of Six thousand nine hundred eighty Six pounds  
of Tobacco Debt and also the Summe of two hundred forty nine pounds of Tobacco  
Costs by the Said Nathaniel about his Suits in this behalfe expended and by the  
Court here of this assent adjudged and the Said John in Mercy  
John Smith C<sup>t</sup>

granted: Ordered that Edward Scott high Sheriffe of this County keepe the Said Thomas  
Welding in safe Custody until he give Spee Bayle to the Auon a<sup>ft</sup>

AND which cometh into C<sup>t</sup> Thomas Tolley of Said County becometh Bayle  
and doth under take for the Said Thomas Welding the payment of the Debt a<sup>ft</sup> &  
Costs thereon due owing if it shall happen that the Said Nathaniel Hyuson shall  
recover Judgment ag<sup>t</sup> the D Thomas in the Auon a<sup>ft</sup> and the Said Thomas the  
C<sup>t</sup> condemnation shall not satisfye nor himselfe to the Custody of the Sher of D County  
deliver or that he the Said Thomas Tolley the body of the Said Thomas Welding  
shall not render e<sup>r</sup>

AND thereupon the Auon is Transmitted to the latter end of this C<sup>t</sup>

the Said Josiah in the Auon a<sup>ft</sup> and the Said Josiah the C<sup>t</sup> condemnation shall  
not satisfye nor himselfe to the Custody of the Sher of Said County deliver or that he  
the
