Being Sworn on the holy Evangelists here in C<sup>t</sup> doth say that the a<sup>ft</sup> George Lumley the Said Deft doth owe unto him the Just Sum of Eight Thousand and pounds of Tobacco upon Acc<sup>t</sup> 020. Therefore it is Considered by the C<sup>t</sup> here that the Said Michael Earle for the a<sup>ft</sup> Sum of Eight Thousand and pounds of Tobacco Damages and also the Sum of two hundred and thirty pounds of Tobacco C<sup>t</sup> by him about his Suite in this behalf expended and by the C<sup>t</sup> here of his a<sup>ft</sup>ent adjudged against the goods Chattels of the Said George Lumley have an Attachment, be the Said Michael giving Security According to Act of Assembly &c

WHEREUPON cometh into C<sup>t</sup> James Harris of this County & Com<sup>th</sup> Security for the a<sup>ft</sup> Michael Earle that if the Said Deft shall w<sup>thin</sup> an year or day from awarding the Said Attachment cometh in & appears to the original Acc<sup>t</sup> makes it appears that he the Said Michael hath been and is Satisfied the Demand a<sup>ft</sup> or shall otherwise in C<sup>t</sup> discount or barr the Said Michael of the Sum or any part thereof he the Said Michael shall make Restitution of the Goods Chattels So Attached & condemned or the value thereof &c

I thereon Endorsed C<sup>t</sup> C<sup>t</sup> for me Edw Scott Just  
William Morris AND the Said Deft being called cometh & the Said J<sup>st</sup> by Michael Earle his atty moves the C<sup>t</sup> that the Said William may give Spee Bayle to the Detention of him the Said Edward. Ordered by the C<sup>t</sup> here that the Said William Morris the Deft give Spee Bayle to the Detention of him likewise that Edward Scott J<sup>st</sup> of Said County keep the Deft in safe Custody until he give Spee Bayle to the Detention

After w<sup>ch</sup> Dennis Sullivan J<sup>st</sup> of Said County here in C<sup>t</sup> cometh Cometh Eagle doth undertake for the Said W<sup>m</sup> Morris of payment of the Damages C<sup>t</sup> if it shall happen that the Said Edward shall obtain Judgment against the Said William in his Plea of Error & the Said W<sup>m</sup> in the Detention shall not Satisfie nor himselfe to the Custody of the Just of Said County & live or that the Said Dennis doth the Body of the Said W<sup>m</sup> shall not receive.  
AND the Deft moves the C<sup>t</sup> here that the Said J<sup>st</sup> may give Bayle to pay C<sup>t</sup> if the Plea should obtaine a Non Suite against the Said Edward. Ordered
