After w^{ch} Francis Bellows of Kent County here in C^t com^{pl} the Decemth
 Bayle & doth undertake for the said Mathias Day the payment of the Debt &
 Costs if it shall happen that the s^{am}e Edward Esq^r shall obtaine Judgment agst
 the s^{am}e Mathias in the s^{am}e Action of Debt the s^{am}e Mathias the Indemnacen that
 not satisfye nor himselfe to the custody of the Sher of Kent County do give or that
 the said Francis the body of s^{am}e Mathias shall not receive

And a dec^{ree} being g^{iv} w^{ch} s^{am}e Court s^{am}e forth and a copy thereof brood
 therewith according to Act of Assembly in that case made, was as followeth viz
