hundred pounds of Tobacco = 500: Therefore it is considered by
the C^{ty} here viz^t this twenty 2^d day of March afd Anno Domini 1708
that the P^{tr} Edward Cash doe recover against the said Matthias Day the afd
Summe of five hundred pounds of Tobacco Debt and also the Summe
of three hundred and one pounds of Tobacco Costs by the said Edward
about his Sute in this behalfe expended & by the C^{ty} here of this afd
adjudged and the said Matthias in money
