 his life time on the twentieth day of Nov. in the year of our Lord Christ one thousand seven
 hundred and two a/c. at a certain place now in Kent County a/c. w. in the Jurisdiction
 of this C. upon himselfe did assume & payed and unto the said John Hyuson fully
 & fully promised that he the said Gerardus the a/c. Sums of seven thousand one hundred

 said John Hyuson nine thousand pounds of Tobacco and thereof he brings suite
