Rule is given to the said Deft to putt in his plea in six hours. otherwise Judgment to go ag<sup>t</sup> him by default.

AND note at this day by this twenty second day of March Anno Domini one thousand seven hundred and fifteen the time given for the said Deft to plead being past and no plea being offered by which the said Pet. may still remaine undefended Therefore it is considered by the Court here by the same day last mentioned. That the aff<sup>n</sup> Pet Samuel Philip have a writ awarded to y<sup>e</sup> Justices of said County. that by the Oaths of Justice &c.
