Last mentioned faithfully promised that he the said Deft. so much Merchantable Tobacco as the afo. last mentioned Liquors and ordinary Accomodations were at the time of the Sale & Delivery thereof at reasonable rates & prices worth & amounted to unto the said ptt when thereunto afterwards required would well and truly pay and Content and the afo. ptt in deed saith that the afo. last mentioned Liquors and ordinary Accomodations sold and delivered as last mentioned at the time of the Sale & Delivery thereof were at reasonable rates and values worth and amounted unto y^e Sum of Eighteen hundred and fifteen pounds of Merchantable Tobacco in manner as in the (last mentioned) and Shew of which the said Deft. then and there last mentioned had Notice & notwithstanding the afo. Deft. his several promises and assumptions afo. in forme afo. made little minding but fraudulently intending the said ptt in that behalf the afo. several Sums of Tobacco in the whole amounting to three Thousand Six hundred and thirty pounds of Tobacco unto the said ptt altho afterwards viz on the thirteenth day of Nov Anno Domini Sevenleen hundred & sixteen and often after he was at the parish afo. in the County afo. in the afo. Jurisdiction thereto by the said ptt required hath not paid nor made Content for the same but that to pay or Content the said Deft. hitherto hath denied and yet denies to the damage of the said ptt Six Thousand pds of Merchantable Tobacco and thereupon he brings Sute Le. Breve of Quo pleg Le. John Doe & Richard Roe
