

Seventy Seven pounds of Tobacco Est of Sute and for that Satisfaction have not thereupon yett been made We Therefore Com. you that by good & Lawfull men of your Bailiwik you make known unto the Said Thomas Pindergras that he be and appear before the Justices of our next County Court to be held at our Court house in the Town of Chester in Said County on the third Thursday in November next to show cause if any he have why Execution should not Issue forth against him for the debt & Est in the Judgment aforesaid and how you shall Execute this writ that y<sup>e</sup> make known unto y<sup>e</sup> Justices of our said Court at the day and place aforesaid if you are not to faile at your will and have y<sup>e</sup> then and there y<sup>e</sup> names of the persons before whom y<sup>e</sup> shall make y<sup>e</sup> same known & this writ we Witness Nathaniel Hyinson Gent chief Justice of our said Court this 22<sup>d</sup> day of August in y<sup>e</sup> third year of our Dominion &c. Anno Dom. 1719

At which said next Court by the nineteenth day of November of same year as mentioned the day of Return of said writ came Simon Wilmer Gent High Sheriff of said County and made return thereof in these words thereon endorsed as fo<sup>l</sup>o<sup>w</sup>eth. To the Justices within mentioned By vertue of y<sup>e</sup> within writ of P<sup>r</sup>is facias to me directed I do certify y<sup>e</sup> I have made known to y<sup>e</sup> within named Thomas Pindergras that he be and appear at the day & place within mentioned to show cause if any he hath why Execution should not go against him before W<sup>m</sup> and John Treco two good & Lawfull men of my Bailiwik as within I am Comanded Simon Wilmer Sher<sup>iff</sup> Kent County and now at this Court came the afo<sup>r</sup> Debt and in his proper person appeared to the afo<sup>r</sup> P<sup>r</sup>is facias.

And the afo<sup>r</sup> p<sup>r</sup>t<sup>r</sup> by Thomas Bowne his atty afo<sup>r</sup> prayd that Judgment might be affirmed for Execution on the Judgment afo<sup>r</sup> the Debt shewing no Cause to the contrary Therefore it is Considered by the Court here by this Twenty first day of November Anno Dom One thousand Seven hundred and Seventeen That Execution Issue forth against the said Debt for the afo<sup>r</sup> Summe of two thousand pounds of Tob<sup>o</sup> the Debt in y<sup>e</sup> Judgment afo<sup>r</sup> and also the Summe of three hundred Seventy Seven pounds of Tobacco Est on the same Judgment which in the whole
