AND the ap^{peal} p^{ro}tt. by his atty ap^{peal} prayd that the ap^{peal} Deft to his Deed
 ap^{peal} may answer. And the ap^{peal} Deft being called came and the
 p^{ro}tt by his ap^{peal} atty prays that the said Deft may give Special Baile
 to the ap^{peal} p^{ro}tt which is granted and that he be kept in Safe Custody
 by the Sheriff of said County untill he shall give Special Baile as ap^{peal}.
 after which Zachariah Mackdoniel of said County here in Court
 cometh and acknowledgeth himself as Special Baile in the ap^{peal} p^{ro}tt
 and doth undertake the payment of the damages ap^{peal} and Cost accruing
 if in Case the ap^{peal} p^{ro}tt shall obtaine Judgment against the said Deft
 in the said p^{ro}tt of Trespass of the Case And the said Deft this
 Condemnation shall not satisfy nor himselfe to the Custody of the
 Sheriff of said County deliver or that the ap^{peal} Zachariah Mackdoniel
 the body of the said Thomas Winn shall not render ~~to~~

after which the ap^{peal} Thomas Winn comes into Court and in his proper
 person appears to the ap^{peal} p^{ro}tt and saith that he cannot pay
 the action ap^{peal} of him the said p^{ro}tt and that he is indebted to the ap^{peal} p^{ro}tt
 the Summe of four hundred eighty three pounds of Tobacco upon Callance
 and is willing that Judgment should be entred for the same and Cost
 thereon accruing. Therefore it is Considered by the Court here viz^t
 This twenty first day of November Anno Domini One Thousand seven
 hundred and Seventeen That the ap^{peal} p^{ro}tt William Smith recover
 against the said Deft. Thomas Winn Junor as well the ap^{peal} Summe of
 four hundred eighty three pounds of Tobacco Damages as also the
 Summe of four hundred seventy seven pounds of Tobacco Cost by the
 ap^{peal} p^{ro}tt. about his Sute in this behalfe Expended and by the Court
 here of his ap^{peal} adjudged and the said Deft in more ~~to~~
