 In Consideration that the aff ptt at the Special instance of the aff Deft
 had then and there done divers Services for the aff Deft and to the
 proper use and behoofe of the aff Deft upon himself assumed and to
 the aff ptt then and there faithfully promised that he the aff
 Deft so much Tobacco as the aff Services reasonably deserved to the
 aff ptt when thereunto afterwards he should be required would well
 and truly pay and Content and the aff ptt made oath that the
 aff last mentioned Services at the time of the performing of the
 same reasonably deserved the Summe of Six hundred and twenty Eight
 pounds of Merchantable Tobacco in the manner as in the Auo. Sett.
 hereunto annexed sett forth of which the aff Deft then and there had
 notice . . . AND that whereas also the aff ptt and aff Deft viz afterwards
 the thirtieth day of January in the Year of our Lord Christ one Thousand
 Seven hundred and Sixteen at the parish aff in the County and Jurisdiction
 aff had Accounted together of for and Concerning divers Sums of Tobacco
 to the same ptt by the aff Deft before that time owing & unpaid and
 upon that Accounting the said Deft was found in Arreage to the aff ptt
 in the Summe of Six hundred pounds of Merchantable Tobacco and so
 being found in arreage the aff Deft in consideration thereof afterwards
 viz the thirtieth day of January in the Year aff at the parish County &

 and being hereof indebted the aff Deft In Consideration thereof upon
 himself assumed and to the same ptt viz the aff thirtieth day of January
