 instance and request of the aforesaid Deft had then and there sold & delivered  
 unto the aforesaid Deft and to the proper use and behoofe of the Deft divers  
 goods and Merchandises in an Aco. hereunto Annexed Set forth and  
 at the like Special instance and request of the said Deft and to the  
 proper use and behoofe had given Credit to a Certain Sarah Byrne  
 which in the whole Amounts unto the Sum of Seventeen  
 hundred and Twenty three pounds of Merchantable Tobacco upon  
 himselfe assumed and to the said ptt then and there faithfully  
 promised that he the said Deft the aforesaid Sum of Seventeen hundred and  
 Twenty three pounds of Merchantable Tobacco to the said ptt when  
 thereunto required would well and truly pay and Content And that  
 whereas also the aforesaid Deft afterwards by the aforesaid Twenty eight day of  
 September in the Year aforesaid at the Parish County and Jurisdiction of  
 his Consideration that the aforesaid ptt at the like Special instance &  
 request of the aforesaid Deft had then and there last mentioned sold and  
 delivered to the aforesaid Deft and to the proper use and behoofe of the  
 aforesaid Deft and had given Credit to a Certain Sarah Byrne divers Goods  
 & Merchandises in an Aco. hereunto Annexed Specifically Set forth  
 upon himselfe assumed and to the said ptt then and there last  
 mentioned faithfully promised that he the said Deft so much Merchant-  
 able Tobacco as the aforesaid Goods and Merchandises sold and delivered as  
 aforesaid at the time of the Sale and delivery thereof reasonably were worth  
 and Amounted to and the aforesaid Credit given as aforesaid unto the said ptt  
 would well and truly pay Content and the aforesaid ptt in deed saith  
 that the aforesaid Goods & Merchandises sold & delivered as aforesaid at the time of  
 the Sale and delivery thereof at reasonable rates & prices and the Credit  
 given as last mentioned reasonably were worth & amounted unto the  
 Sum of Seventeen hundred & Twenty three pounds of Merchantable  
 Tobacco in Manner and form as in the said Aco Set forth of which the  
 aforesaid Deft by the aforesaid ptt then and there last mentioned had Notice  
 never the less the aforesaid Deft his several promises and assumptions  
 aforesaid in form aforesaid made little regarding but fraudulently intending them  
 the said ptt in that behalfe to deceive and defraud the aforesaid several  
 Sumes of Tobacco in the whole Amounting unto the Sum of Three  
 thousand four hundred and forty Six pounds to the said ptt or to any of  
 them which not paid nor made Content for the Same altho the said Deft  
 he the said Deft the eighteenth day of October in the Year aforesaid at the  
 parish
