[8-307.] 8-310. Termination of provisions of certain sections in subtitle.

Subject to the evaluation and reestablishment provisions of the Program Evaluation Act, [§§ 8-301, 8-302(a)(1), (b), (c), and (d), 8-303, 8-304, 8-305, and 8-306] THE PROVISIONS of this subtitle relating to the Board of Savings and Loan Association Commissioners and the Division of Savings and Loan Associations and relating to the regulation of savings and loan associations are of no effect and may not be enforced after July 1, 1992.

Subtitle 4. Orders and Hearings

8-401. Orders of Division Director.

(a) Authority.

The Division Director may issue orders [to]:

- (1) TO compel a savings and loan association,-HOLDING COMPANY,-OR-SUBSIDIARY OR RELATED ENTITY to comply with[:
 - (1) Its] ITS charter or bylaws,[;
 - (2) Any] ANY applicable law,[;] or
- [(3) Any] ANY rule or regulation [of the Board of Commissioners.]; OR
