- A MINORITY BUSINESS ENTERPRISE WITHIN THE MEANING WHERE THE ACTUAL MANAGEMENT THE BUSINESS INDIVIDUALS OTHER THAN THE OWNER, THOSE PERSONS ULTIMATE POWER TO HIRE AND FIRE THE MANAGERS MAY, WHO HAVE THE THIS SECTION, BE CONSIDERED AS CONTROLLING THE PURPOSES OF THE BUSINESS.
- ALL SECURITIES WHICH CONSTITUTE OWNERSHIP A CORPORATION FOR PURPOSES OF ESTABLISHING MINORITY ENTERPRISE UNDER THIS SECTION SHALL BUSINESS BY MINORITIES. NO SECURITIES HELD IN TRUST, A MINOR, SHALL BE CONSIDERED AS HELD BY MINORITIES THE OWNERSHIP OR CONTROL OF CORPORATION. IN DETERMINING Α
- CONTRIBUTIONS OF CAPITAL OR EXPERTISE INTERESTS TO ACQUIRE OWNERS MINORITY SHALL BE REAL AND SUBSTANTIAL.
