

subdivisions-to-adopt-certain-laws,-ordinances,-rules,-and regulations,-requiring-that-a-person-who-operates-a-food establishment-must-be-licensed-by-the-Department,-providing that-under-certain-circumstances-a-license-issued-by-a certain-political-subdivision-constitutes-the-license required-under-this-Act,-establishing-license-requirements, providing-for-a-license-fee-and-authorizing-the-Department and-local-health-departments-to-assess-and-collect,-and provide-for-exemptions-from-certain-fees,-allowing-the Department-to-exempt-certain-facilities-from-the-license fee,-providing-that-the-Department-may-suspend,-revoke,-or modify-a-food-establishment-license-under-certain circumstances,-providing-for-renewal-of-a-license,-allowing for-the-inspection-of-any-food-establishment,-providing-for notice-orders,-hearings,-and-other-methods-of-enforcing this-Act,-requiring-that-certain-plans-and-specifications-be submitted-to-and-approved-by-the-Department-or-appropriate county-health-department-before-a-food-establishment-is constructed,-altered,-or-remodeled,-allowing-the-Department of-Health-and-Mental-Hygiene-and-the-Department-of Agriculture-to-inspect-certain-foods-for-wholesomeness, providing-an-exemption-from-this-Act-for-certain-group homes,-providing-that-certain-structures-and-equipment-in-a food-establishment-must-be-kept-in-a-clean-and-sanitary condition-and-providing-certain-criteria-for-what constitutes-an-unclean-or-unsanitary-condition,-requiring that-certain-food-establishments-contain-certain-facilities, requiring-that-each-food-service-facility-post-a-certain lifesaving-chart,-prohibiting-a-person-from-sleeping-in certain-portions-of-a-food-establishment,-providing-that certain-individuals-may-not-knowingly-be-employed-or knowingly-work-in-a-food-establishment,-providing-for-the registration-of-certain-soft-drinks,-providing-for-the issuance,-renewal,-revocation,-and-denial-of-a-soft-drink registration,-providing-for-the-proper-cleaning-of-soft drink-containers,-prohibiting-the-sale-of-soft-drink containers-with-certain-detachable-metal-tab-openings, providing-for-the-licensing-and-regulation-of-the-supply, collecting,-bottling,-and-delivering-of-bottled-drinking water,-requiring-that-containers-of-crab-meat-be-marked-in-a certain-manner-and-contain-certain-information,-requiring that-all-crab-meat-sold-in-this-State-meet-certain standards,-prohibiting-the-handling-and-sale-of-certain-crab meat-and-shellfish,-allowing-the-Department-of-Health-and Mental-Hygiene-to-detain,-seize,-and-condemn-certain-crab meat,-shellfish,-and-food-containing-shellfish,-prohibiting a-person-from-importing-certain-shellfish-or-food-containing shellfish-into-the-State,-providing-criminal-and-civil penalties-for-violations-of-this-Act,-providing-injunctive powers,-and-generally-relating-to-the-licensing,-regulation, and-enforcement-of-certain-foods-and-food-establishments.
