

(2)(ii) -- ALL LICENSE FEES SHALL BE PAID TO THE LOCAL HEALTH DEPARTMENT OR CHIEF FINANCIAL OFFICER OF THE COUNTY GOVERNING BODY OR BALTIMORE CITY.

(2) -- EXCEPT IN BALTIMORE CITY AND MONTGOMERY COUNTY, A LICENSE FEE UNDER THIS SUBSECTION MAY NOT EXCEED \$150.

(B) -- FOR ANY OTHER FOOD ESTABLISHMENT LICENSE:

(1) -- THE DEPARTMENT SHALL ESTABLISH A LICENSE FEE SCHEDULE BASED ON THE ANTICIPATED COST OF LICENSING, INSPECTING, AND REGULATING FOOD ESTABLISHMENTS.

(2) -- ALL FEES COLLECTED SHALL GO INTO THE GENERAL FUND.

(3) -- A LICENSE FEE MAY NOT EXCEED \$150.

(C) -- THE DEPARTMENT MAY EXEMPT THE FEE REQUIRED UNDER THIS SUBSECTION FOR FOOD ESTABLISHMENTS OWNED AND OPERATED BY THE STATE OR ANY POLITICAL SUBDIVISION.

(D) -- EXCEPT AS PROVIDED IN THIS SECTION, A POLITICAL SUBDIVISION MAY NOT COLLECT ANY FEE FOR A FOOD ESTABLISHMENT LICENSE.

#### 4-309.

(A)(1) -- EXCEPT AS PROVIDED IN THE ADMINISTRATIVE PROCEDURE ACT, AND IN PARAGRAPHS (2) AND (3) OF THIS SUBSECTION, AND UNLESS IT IS RENEWED FOR ANOTHER TERM, A LICENSE EXPIRES 1 YEAR FROM THE DATE OF ISSUANCE OR RENEWAL OR AS PROVIDED BY LOCAL LAW, ORDINANCE, OR REGULATION IN ACCORDANCE WITH § 4-304(B) AND (C) OF THIS SUBTITLE.

(2) -- EXCEPT AS PROVIDED IN THE ADMINISTRATIVE PROCEDURE ACT, AND UNLESS IT IS RENEWED FOR ANOTHER TERM, A LICENSE TO OPERATE A CRAB MEAT PLANT EXPIRES ON APRIL 1 OF EACH YEAR.

(3) -- EXCEPT AS PROVIDED IN THE ADMINISTRATIVE PROCEDURE ACT, AND UNLESS IT IS RENEWED FOR ANOTHER TERM, A LICENSE TO OPERATE A SHELLFISH PLANT EXPIRES ON AUGUST 31 OF EACH YEAR.

(B) -- AT LEAST 1 MONTH BEFORE THE LICENSE EXPIRES, THE DEPARTMENT SHALL SEND TO THE LICENSEE, BY FIRST CLASS MAIL TO THE LAST KNOWN ADDRESS OF THE LICENSEE, A RENEWAL NOTICE THAT STATES:

(1) -- THE DATE ON WHICH THE CURRENT LICENSE EXPIRES, AND

(2) -- THE DATE BY WHICH THE COMPLETE COMPLETED RENEWAL APPLICATION MUST BE RECEIVED BY THE DEPARTMENT FOR THE RENEWAL TO BE ISSUED AND MAILED BEFORE THE LICENSE EXPIRES.
