- (K) (1) A TRANSIENT VENDOR MAY NOT ENGAGE IN BUSINESS WITHOUT FIRST OBTAINING THE NECESSARY LICENSE REQUIRED UNDER THIS SECTION.
- (2) THIS SECTION DOES NOT EXEMPT A VENDOR FROM OBTAINING ANY OTHER LICENSE OR PERMIT OF THE UNITED STATES, THE STATE, FREDERICK COUNTY, OR ANY OTHER MUNICIPAL CORPORATION IN FREDERICK COUNTY, OR FROM BEING SUBJECTED TO LIABILITY, TAX LIABILITY, OR ANY OTHER REGULATIONS THAT MAY BE APPLICABLE IN THE UNITED STATES, THE STATE, FREDERICK COUNTY, OR ANY OTHER MUNICIPAL CORPORATION IN FREDERICK COUNTY.
- (3) UNLESS OTHERWISE PERMITTED BY LAW, A LICENSED TRANSIENT VENDOR MAY NOT SELL GOODS, WARES, OR MERCHANDISE ON SUNDAY.
- (L) A PERSON WHO ENGAGES IN A TRANSIENT BUSINESS IN VIOLATION OF THIS SECTION IS GUILTY OF A MISDEMEANOR AND ON CONVICTION, SHALL BE SUBJECT TO A FINE NOT TO EXCEED \$2,500 OR IMPRISONMENT FOR NOT MORE THAN 1 YEAR OR BOTH.
- (M) LAW ENFORCEMENT PERSONNEL FROM ANY MUNICIPAL CORPORATION IN FREDERICK COUNTY, FREDERICK COUNTY, AND THE STATE MAY ENFORCE COMPLIANCE WITH THE PROVISIONS OF THIS SECTION.
- SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect July 1, 1986.

CHAPTER 681

(Senate Bill 632)

AN ACT concerning

Group Health - Insurance Coverage of Surviving Spouses

FOR the purpose of requiring group health insurance contracts to offer the spouse and dependent children of a deceased employee the option to continue coverage; specifying the eligibility for and duration of the continuation coverage; specifying the maximum period a spouse or dependent child may continue coverage; prohibiting continuation coverage from being conditional upon evidence of insurability or waiting periods; requiring continuation coverage to be identical to coverage offered to similarly situated individuals whose spouse is not deceased; specifying a time period and procedure for the surviving spouse to elect continuation coverage; requiring certificates issued under group insurance contracts to specify the terms and
