

SEVERAL PHYSICIANS, THE JOB DESCRIPTION SHALL BE FILED BY THE LICENSED PHYSICIAN WHO:

(i) HAS OVERALL AUTHORITY OVER THE PHYSICIAN ASSISTANT, AND

(ii) IS RESPONSIBLE FOR ENSURING THAT THE TERMS OF THE JOB DESCRIPTION ARE SATISFIED.

(G) (1) ANY SUBSTANTIAL CHANGE IN THE MEDICAL ACTS TO BE DELEGATED, EXTENT OF SUPERVISION TO BE PROVIDED, OR PRACTICE SETTING SHALL REQUIRE THE FILING OF AN AMENDED JOB DESCRIPTION TO BE APPROVED BY THE BOARD AND COMMITTEE.

(2) UPON TERMINATION OF A PHYSICIAN ASSISTANT'S EMPLOYMENT, BOTH THE PHYSICIAN ASSISTANT AND SUPERVISING PHYSICIAN SHALL NOTIFY THE BOARD AND COMMITTEE.

(H) A SUPERVISING PHYSICIAN MAY NOT DELEGATE THE DUTY OF INDEPENDENTLY PRESCRIBING OR DISPENSING DRUGS TO A PHYSICIAN ASSISTANT.

TO APPLY FOR A LICENSE OR APPROVAL OF A JOB DESCRIPTION APPLICATION, AN APPLICANT OR LICENSEE SHALL:

(1) SUBMIT AN APPLICATION TO THE BOARD AND COMMITTEE ON THE FORM THAT THE BOARD AND COMMITTEE REQUIRE, AND

(2) PAY TO THE BOARD THE FEE SET BY THE BOARD AND COMMITTEE.

14-5-306.

(A) AN APPLICANT WHO OTHERWISE IS QUALIFIED FOR A LICENSE IS ENTITLED TO BE EXAMINED AS PROVIDED IN THIS TITLE.

(B) IF THE BOARD AND COMMITTEE GIVE AN EXAMINATION, THE EXAMINATION SHALL BE GIVEN AT LEAST TWICE EACH YEAR AT THE TIMES AND PLACES THE BOARD AND COMMITTEE DETERMINE.

(C) THE BOARD SHALL NOTIFY EACH QUALIFIED APPLICANT OF THE TIME AND PLACE OF ANY EXAMINATION.

(D) THE BOARD AND COMMITTEE SHALL DETERMINE THE SUBJECTS, SCOPE, FORM, AND PASSING SCORE FOR ANY EXAMINATION GIVEN UNDER THIS SUBTITLE.

THE BOARD SHALL ISSUE A LICENSE TO ANY APPLICANT WHO MEETS THE REQUIREMENTS OF THIS TITLE.
