

DELEGATED MEDICAL ACT BEYOND THE SCOPE OF THE CERTIFICATE AND WHICH IS CONSISTENT WITH A JOB DESCRIPTION APPROVED BY THE BOARD.

14.5-402.

(A) EXCEPT AS OTHERWISE PROVIDED UNDER THIS TITLE, A PERSON MAY NOT REPRESENT OR IMPLY TO THE PUBLIC BY USE OF THE TITLE "CERTIFIED PHYSICIAN ASSISTANT", BY OTHER TITLE, BY DESCRIPTION OF SERVICES, METHODS, OR PROCEDURES THAT THE PERSON IS CERTIFIED TO PRACTICE AS A PHYSICIAN ASSISTANT IN THE STATE.

(B) UNLESS CERTIFIED TO PRACTICE AS A PHYSICIAN ASSISTANT UNDER THIS TITLE, A PERSON MAY NOT USE THE WORDS OR TERMS "PHYSICIAN ASSISTANT", "CERTIFIED PHYSICIAN ASSISTANT", OR "P.A."

14.5-403.

A PERSON WHO VIOLATES § 14.5-401 OR § 14.5-402 OF THIS SUBTITLE:

(1) IS GUILTY OF A MISDEMEANOR AND ON CONVICTION IS SUBJECT TO A FINE NOT EXCEEDING ~~§1,000~~ \$5,000 OR IMPRISONMENT NOT EXCEEDING 1-YEAR 5 YEARS OR BOTH; AND

(2) SHALL LOSE CERTIFICATION AS A PHYSICIAN ASSISTANT UNDER THIS TITLE.

THIS TITLE MAY BE CITED AS THE "MARYLAND PHYSICIAN ASSISTANTS ACT".

SUBJECT TO THE EVALUATION AND REESTABLISHMENT PROVISIONS OF THE MARYLAND PROGRAM EVALUATION ACT, THIS TITLE AND ALL REGULATIONS ADOPTED UNDER THIS TITLE SHALL TERMINATE AND BE OF NO EFFECT AFTER JULY 1, 1996.

(D) NOTWITHSTANDING THE PROVISIONS OF SUBSECTION (A) OF THIS SECTION, UNLESS THE POLICY, CONTRACT, OR CERTIFICATE EXPRESSLY PROVIDES FOR REIMBURSEMENT OF ANY SERVICE WHICH IS WITHIN THE LAWFUL SCOPE OF PRACTICE OF A PHYSICIAN ASSISTANT CERTIFIED UNDER THE HEALTH OCCUPATIONS ARTICLE, THE PROVISIONS OF TITLE 14.5 OF THE HEALTH OCCUPATIONS ARTICLE GOVERNING THE CERTIFICATION AND REGULATION OF PHYSICIAN ASSISTANTS MAY NOT BE CONSTRUED TO ENTITLE THE INSURED OR ANY OTHER PERSON COVERED BY THE POLICY, CONTRACT, OR CERTIFICATE TO REIMBURSEMENT FOR ANY
