

(3) THE DECISION OF THE BOARD OF ARBITRATION, OR A MAJORITY OF ITS MEMBERS, SHALL BE FINAL AND BINDING ON ALL OF THE PARTIES TO THE APPEAL.

(4) THE MEMBERS OF THE BOARD OF ARBITRATION SHALL BE PAID \$25 EACH, THE TOTAL OF WHICH SHALL BE DEPOSITED WITH THE BOARD BY THE APPLICANT.

(5) IF THE BOARD OF ARBITRATION AFFIRMS THE DECISION OF THE BOARD, THE MONEY DEPOSITED SHALL BE USED TO PAY THE BOARD OF ARBITRATION MEMBERS.

(6) IF THE BOARD'S DECISION IS REVERSED, THE BOARD OF ARBITRATION MEMBERS SHALL BE PAID \$25 EACH BY THE TREASURER OF QUEEN ANNE'S COUNTY, AND THE DEPOSIT SHALL BE RETURNED TO THE APPLICANT.

(7) THE APPLICANT SHALL STILL BE RESPONSIBLE FOR THE \$35 APPLICATION FEE.

(H) THE BOARD HAS FULL POWER AND AUTHORITY TO HEAR AND DETERMINE GRIEVANCES CONCERNING LICENSEES.

(I) THE BOARD MAY ADOPT RULES AND REGULATIONS FOR THE ISSUANCE OF A LICENSE OF LIMITED JURISDICTION FOR A LIMITED PERIOD OF TIME WHEN IN THE DISCRETION OF THE BOARD CIRCUMSTANCES REQUIRE IT TO BE ISSUED.

(J) (1) A PERSON MAY NOT BE LICENSED AS A MASTER ELECTRICIAN UNDER THIS SUBTITLE UNLESS THE PERSON CARRIES GENERAL LIABILITY INSURANCE IN AN AMOUNT OF AT LEAST ~~\$100,000~~ \$300,000 AND PROPERTY DAMAGE INSURANCE IN AN AMOUNT OF AT LEAST ~~\$300,000~~ \$100,000.

(2) AN APPLICANT FOR THE ISSUANCE OR RENEWAL OF A LICENSE SHALL FURNISH THE BOARD WITH PROOF THAT THE INSURANCE HAS BEEN OBTAINED BEFORE THE BOARD SHALL ISSUE OR RENEW THE LICENSE.

(3) WITHIN 10 DAYS OF THE CANCELLATION DATE, A PERSON LICENSED AS A MASTER ELECTRICIAN SHALL FORWARD TO THE BOARD ANY NOTICE OF CANCELLATION OF THE MASTER ELECTRICIAN'S GENERAL LIABILITY INSURANCE.

No person granted a license under the provisions of this subtitle shall install or repair electrical wires, conductors, apparatus for electric light, heat or power purposes after the expiration of [said licenses] THE PERSON'S LICENSE, or after [said] THE PERSON'S license [shall have] HAS been revoked as herein provided, unless the [said] PERSON'S license or renewal of same shall have been renewed as herein provided; provided, that any person so granted a license under the provisions of this [sub-title] TITLE (unless the said license shall have been revoked as hereinafter provided) shall be granted a renewal of
