SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND, That the Laws of Maryland read as follows:

Article - Courts and Judicial Proceedings

2-508.

(A) IN ANNE ARUNDEL COUNTY, THERE IS THE OFFICE OF THE DIRECTOR OF ASSIGNMENTS OF THE CIRCUIT COURT.

(B) THE OFFICE OF THE DIRECTOR OF ASSIGNMENTS OF THE CIRCUIT COURT SHALL:

(1) SCHEDULE ALL CIVIL CASES BEFORE THE CIRCUIT COURT; AND

(2) PERFORM ALL OTHER DUTIES AS DIRECTED BY THE ADMINISTRATIVE JUDGES OF THE CIRCUIT AND ~~COUNTY--ADMINISTRATIVE~~ JUDGES-OF ANNE ARUNDEL COUNTY.

(C) PURSUANT TO THE MARYLAND RULES, THE COUNTY ADMINISTRATIVE JUDGE OF ANNE ARUNDEL COUNTY SHALL:

(1) APPOINT THE DIRECTOR OF ASSIGNMENTS; AND

(2) SUPERVISE THE FUNCTIONS AND EMPLOYEES OF THE OFFICE OF THE DIRECTOR OF ASSIGNMENTS.

(D) (1) ANNE ARUNDEL COUNTY SHALL PAY ALL EXPENSES OF THE ~~OFFICE-OF-THE~~ DIRECTOR AND THE OFFICE OF ASSIGNMENTS OF THE CIRCUIT COURT FOR ANNE ARUNDEL COUNTY, ~~INCLUDING-THE-SALARY-AND~~ EXPENSES-FOR-THE-DIRECTOR-OF--ASSIGNMENTS EXCLUDING SALARY AND FRINGE BENEFITS FOR OTHER EMPLOYEES OF THE OFFICE OF ASSIGNMENTS.
