"FIRM" MEANS A PARTNERSHIP OR CORPORATION.

(E) FIRM MEMBER.

"FIRM MEMBER" MEANS A PARTNER OF A PARTNERSHIP OR AN OFFICER OR DIRECTOR OF A CORPORATION.

(F) INCLUDES; INCLUDING.

"INCLUDES" OR "INCLUDING" MEANS INCLUDES OR INCLUDING BY WAY OF ILLUSTRATION AND NOT BY WAY OF LIMITATION.

(G) LICENSE.

"LICENSE" MEANS, UNLESS THE CONTEXT REQUIRES OTHERWISE, A LICENSE ISSUED BY THE SUPERINTENDENT TO CONDUCT A BUSINESS TO PROVIDE PRIVATE DETECTIVE SERVICES.

(H) LICENSED PRIVATE DETECTIVE AGENCY.

"LICENSED PRIVATE DETECTIVE AGENCY" MEANS, UNLESS THE CONTEXT REQUIRES OTHERWISE, A PERSON WHO IS LICENSED BY THE SUPERINTENDENT TO CONDUCT A BUSINESS THAT PROVIDES PRIVATE DETECTIVE SERVICES.

(I) PERSON.

"PERSON" MEANS AN INDIVIDUAL, RECEIVER, TRUSTEE, GUARDIAN, PERSONAL REPRESENTATIVE, FIDUCIARY, OR REPRESENTATIVE OF ANY KIND AND ANY PARTNERSHIP, FIRM, ASSOCIATION, CORPORATION, OR OTHER ENTITY.

(J) PRIVATE DETECTIVE.

"PRIVATE DETECTIVE" MEANS AN INDIVIDUAL WHO PERSONALLY PROVIDES PRIVATE DETECTIVE SERVICES.

(K) PRIVATE DETECTIVE AGENCY.

"PRIVATE DETECTIVE AGENCY" MEANS ANY PERSON WHO CONDUCTS A BUSINESS THAT PROVIDES PRIVATE DETECTIVE SERVICES.

- (L) PROVIDE PRIVATE DETECTIVE SERVICES.
- (1) "PROVIDE PRIVATE DETECTIVE SERVICES" MEANS TO PROVIDE ANY OF THE FOLLOWING SERVICES FOR WHICH COMPENSATION IS CHARGED:
 - (I) TO CONDUCT AN INVESTIGATION CONCERNING:
- 1. ANY CRIME OR WRONG COMMITTED, ASSUMED TO HAVE BEEN COMMITTED, OR THREATENED TO BE COMMITTED;
