- (1) CONDUCT A BUSINESS THAT PROVIDES PRIVATE DETECTIVE SERVICES FOR COMPENSATION;
- (2) MAINTAIN AN OFFICE FOR THE CONDUCT OF THE BUSINESS AT EACH LOCATION STATED IN THE AGENCY LICENSE CERTIFICATE:
- (3) EMPLOY INDIVIDUALS AS PRIVATE DETECTIVES TO PROVIDE PRIVATE DETECTIVE SERVICES TO THE PUBLIC ON BEHALF OF THE LICENSEE:
- (4) ENGAGE IN THE BUSINESS OF PROVIDING SECURITY GUARDS FOR HIRE, AS PROVIDED UNDER PART V OF THIS SUBTITLE; AND
- (5) REPRESENT THE LICENSEE TO THE PUBLIC AS A PRIVATE DETECTIVE AGENCY.
- 556. TERM AND RENEWAL OF LICENSE.
 - (A) TERM OF LICENSE.

A LICENSE EXPIRES ON THE APRIL 30 AFTER ITS EFFECTIVE DATE, UNLESS THE LICENSE IS RENEWED FOR A 1-YEAR TERM AS PROVIDED IN THIS SECTION.

(B) RENEWAL NOTICE.

AT LEAST 1 MONTH BEFORE THE LICENSE EXPIRES, THE SUPERINTENDENT SHALL SEND TO THE LICENSEE, BY MAIL TO THE LAST KNOWN ADDRESS OF THE LICENSEE, A RENEWAL NOTICE THAT STATES:

- (1) THE DATE ON WHICH THE CURRENT LICENSE EXPIRES:
- (2) THAT THE SUPERINTENDENT MUST RECEIVE THE RENEWAL APPLICATION AND THE ANNUAL STATEMENTS, AS REQUIRED UNDER § 557 OF THIS SUBTITLE, ON OR BEFORE APRIL 15 FOR THE RENEWAL TO BE ISSUED AND MAILED BEFORE THE LICENSE EXPIRES;
 - (3) THE AMOUNT OF THE RENEWAL FEE;
- (4) THAT IF THE ANNUAL STATEMENTS ARE NOT RECEIVED ON OR BEFORE APRIL 15, A FEE OF \$10 PER DAY SHALL BE CHARGED AGAINST THE LICENSEE UNTIL THE STATEMENTS ARE RECEIVED; AND
- (5) THAT THE SUBMISSION OF A FALSE STATEMENT IN THE RENEWAL APPLICATION OR IN THE ANNUAL STATEMENTS IS CAUSE FOR REVOCATION OF THE LICENSE.
 - (C) APPLICATIONS FOR RENEWAL.

THE LICENSEE PERIODICALLY MAY RENEW THE LICENSE FOR AN ADDITIONAL 1-YEAR TERM, IF, THE LICENSEE:

(1) OTHERWISE IS ENTITLED TO BE LICENSED;
