## (2) PAYS TO THE SUPERINTENDENT:

- (I) A RENEWAL FEE OF:
- 1. \$200, IF THE LICENSEE IS AN INDIVIDUAL: OR
  - 2. \$400, IF THE LICENSEE IS A FIRM; AND
- (II) ANY LATE FEE REQUIRED UNDER § 557 OF THIS SUBTITLE: AND
  - (3) SUBMITS TO THE SUPERINTENDENT:
- (I) A RENEWAL APPLICATION ON THE FORM THAT THE SUPERINTENDENT PROVIDES; AND
- (II) THE ANNUAL STATEMENTS REQUIRED UNDER § 557 OF THIS SUBTITLE.
- 557. ANNUAL STATEMENTS.
  - (A) IN GENERAL.
- AS A CONDITION FOR LICENSE RENEWAL, A LICENSEE SHALL SUBMIT WITH THE RENEWAL APPLICATION THE FOLLOWING ANNUAL STATEMENTS AND DOCUMENTS TO THE SUPERINTENDENT:
- (1) A CERTIFICATION OR, AS AUTHORIZED BY THE SUPERINTENDENT, OTHER DOCUMENTATION THAT FOR THE PAST CALENDAR YEAR ALL WITHHOLDING AND SOCIAL SECURITY TAXES HAVE BEEN PAID BY THE LICENSEE;
- (2) A CERTIFICATION OR, AS AUTHORIZED BY THE SUPERINTENDENT, OTHER DOCUMENTATION THAT FOR THE PAST CALENDAR YEAR ALL OTHER OBLIGATIONS PAYABLE FOR OR ON BEHALF OF THE EMPLOYEES OF THE LICENSEE TO THE STATE OR THE FEDERAL GOVERNMENT HAVE BEEN PAID BY THE LICENSEE;
- (3) A CERTIFICATE FROM AN INSURANCE CARRIER OR, AS AUTHORIZED BY THE SUPERINTENDENT, OTHER DOCUMENTATION SHOWING THAT WORKMEN'S COMPENSATION INSURANCE FOR EMPLOYEES OF THE LICENSEE IS IN EFFECT; AND
- (4) A RECEIPT FROM THE INCOME TAX DIVISION OF THE COMPTROLLER'S OFFICE OR, AS AUTHORIZED BY THE SUPERINTENDENT, OTHER DOCUMENTATION SHOWING THAT THE STATE INCOME TAX OF THE PRIVATE DETECTIVE AGENCY HAS BEEN PAID FOR THE PAST CALENDAR YEAR.
  - (B) LATE FEE.
