- (6) WILLFULLY MAKES A FALSE STATEMENT OR MISREPRESENTATION THAT AN INDIVIDUAL IS OR WAS IN THE EMPLOY OF THE APPLICANT OR LICENSEE;
- (7) WILLFULLY MAKES A FALSE STATEMENT OR MISREPRESENTATION IN ANY RENEWAL APPLICATION, ANNUAL STATEMENT, OR IN ANY OTHER REPORT OR DOCUMENT THAT THE SUPERINTENDENT REQUIRES TO BE SUBMITTED;
- (8) FAILS TO NOTIFY THE SUPERINTENDENT OF ANY CHANGE IN THE MEMBERSHIP OF THE PRIVATE DETECTIVE FIRM OR IN THE ADDRESS OF THE PRINCIPAL OFFICE OR ANY BRANCH OFFICE OF A LICENSEE;
- (9) FAILS TO MAINTAIN A BOND AS REQUIRED BY § 593 OF THIS SUBTITLE;
- (10) FAILS TO MAINTAIN THE LIABILITY INSURANCE REQUIRED UNDER § 594 OF THIS SUBTITLE; OR
 - (11) VIOLATES ANY OTHER PROVISION OF THIS SUBTITLE.
 - (B) IMPUTATION OF ACT OR OMISSION.
