ANY INDIVIDUAL WHOSE APPLICATION FOR CERTIFICATION AS A PRIVATE DETECTIVE HAS BEEN DENIED UNDER § 574 OF THIS SUBTITLE OR WHOSE CERTIFICATION AS A PRIVATE DETECTIVE HAS BEEN SUSPENDED OR REVOKED UNDER § 574 OF THIS SUBTITLE MAY TAKE AN APPEAL AS ALLOWED IN §§ 10-215 AND 10-216 OF THE STATE GOVERNMENT ARTICLE.

PART V. SECURITY GUARD SERVICES.

- 579. LICENSE AND CERTIFICATION REQUIREMENTS.
 - (A) BUSINESS REQUIRED TO BE LICENSED.

A PERSON SHALL BE LICENSED AS A PRIVATE DETECTIVE AGENCY BEFORE THE PERSON MAY ENGAGE IN THE BUSINESS OF PROVIDING SECURITY GUARDS FOR HIRE.

- (B) SECURITY GUARD REQUIRED TO BE CERTIFIED.
- (1) EXCEPT AS PROVIDED UNDER PARAGRAPH (2) OF THIS SUBSECTION, A LICENSED PRIVATE DETECTIVE AGENCY MAY PROVIDE AN INDIVIDUAL FOR HIRE AS A SECURITY GUARD ONLY IF THE INDIVIDUAL IS CERTIFIED BY THE SUPERINTENDENT AS A PRIVATE DETECTIVE OR AS A SECURITY GUARD.
- (2) A LICENSED PRIVATE DETECTIVE AGENCY MAY PROVIDE AN UNCERTIFIED INDIVIDUAL FOR HIRE AS A SECURITY GUARD IF:
- (I) THE PRIVATE DETECTIVE AGENCY HAS SUBMITTED TO THE SUPERINTENDENT THE INDIVIDUAL'S APPLICATION FOR CERTIFICATION AS A SECURITY GUARD, FINGERPRINT CARDS, AND RECORDS FEE AS REQUIRED UNDER § 580(B) OF THIS SUBTITLE; AND
- (II) THE INDIVIDUAL'S APPLICATION HAS NOT BEEN DISAPPROVED BY THE SUPERINTENDENT.
- 580. QUALIFICATIONS FOR CERTIFICATION AS SECURITY GUARD; APPLICATION.
 - (A) QUALIFICATIONS.

TO QUALIFY FOR CERTIFICATION AS A SECURITY GUARD, AN INDIVIDUAL SHALL:

- (1) MEET THE STANDARDS SET BY THE SUPERINTENDENT:
- (2) BE AN EMPLOYEE OF OR AN APPLICANT FOR EMPLOYMENT WITH A LICENSED PRIVATE DETECTIVE AGENCY;
- (3) SUBMIT TO THE PRIVATE DETECTIVE AGENCY FOR FORWARDING TO THE SUPERINTENDENT:
- (I) A SWORN APPLICATION ON THE FORM THE SUPERINTENDENT PROVIDES; AND
