(II) 2 SETS OF FINGERPRINT CARDS MARKED WITH THE APPLICANT'S FINGERPRINTS; AND

- (4) PAY TO THE PRIVATE DETECTIVE AGENCY FOR FORWARDING TO THE SUPERINTENDENT A RECORDS FEE SET BY THE SUPERINTENDENT, NOT TO EXCEED THE FEE CHARGED THE MARYLAND STATE POLICE BY THE FEDERAL BUREAU OF INVESTIGATION FOR A FINGERPRINT CARD RECORD CHECK.
  - (B) SUBMISSION OF APPLICATIONS.

ON RECEIPT FROM AN APPLICANT FOR CERTIFICATION AS A SECURITY GUARD, A PRIVATE DETECTIVE AGENCY SHALL FORWARD TO THE SUPERINTENDENT THE APPLICANT'S APPLICATION FORM, FINGERPRINT CARDS, AND RECORDS FEE.

581. CERTIFICATION OF INDIVIDUALS QUALIFIED AS SECURITY GUARDS; NOTICE OF DISAPPROVAL.

## (A) CERTIFICATION.

THE SUPERINTENDENT SHALL CERTIFY AS A SECURITY GUARD EACH INDIVIDUAL WHOSE APPLICATION HAS BEEN SUBMITTED AS REQUIRED BY THIS SUBTITLE AND WHO MEETS THE REQUIREMENTS OF THIS SUBTITLE.

(B) NOTICE OF DISAPPROVAL.

WITHIN 5 DAYS AFTER THE DECISION TO DISAPPROVE AN APPLICANT, THE SUPERINTENDENT SHALL SEND WRITTEN NOTICE OF DISAPPROVAL TO THE PRIVATE DETECTIVE AGENCY THAT SUBMITTED THE APPLICATION.

582. SCOPE OF SECURITY GUARD CERTIFICATION.

WHILE IT IS EFFECTIVE, CERTIFICATION AS A SECURITY GUARD AUTHORIZES THE CERTIFIED INDIVIDUAL TO REPRESENT TO THE PUBLIC THAT THE INDIVIDUAL IS CERTIFIED BY THE SUPERINTENDENT FOR EMPLOYMENT AS A SECURITY GUARD.

583. ISSUANCE AND FORM OF SECURITY GUARD CERTIFICATION CARD.

## (A) ISSUANCE.

THE SUPERINTENDENT SHALL ISSUE TO EACH INDIVIDUAL WHO IS CERTIFIED AS A SECURITY GUARD UNDER THIS SUBTITLE A CERTIFICATION CARD THAT IDENTIFIES THE INDIVIDUAL AS A CERTIFIED SECURITY GUARD.

## (B) FORM.

- (1) SUBJECT TO THE PROVISIONS OF THIS SUBSECTION, THE SUPERINTENDENT SHALL DETERMINE THE FORM AND CONTENT OF THE CARD.
- (2) THE CARD SHALL BE OF A SIZE AND MADE OF MATERIALS APPROPRIATE FOR ITS INTENDED USE, AS PROVIDED UNDER § 584 OF THIS SUBTITLE.
