

EXCEPT AS OTHERWISE PROVIDED IN TITLE 10, SUBTITLE 4 OF THE STATE GOVERNMENT ARTICLE, BEFORE THE SUPERINTENDENT TAKES ANY ACTION UNDER § 586 OF THIS SUBTITLE, THE SUPERINTENDENT SHALL GIVE THE INDIVIDUAL AGAINST WHOM THE ACTION IS CONTEMPLATED AN OPPORTUNITY FOR A HEARING BEFORE THE SUPERINTENDENT.

(B) APPLICATION OF CONTESTED CASE PROVISIONS.

THE SUPERINTENDENT SHALL GIVE NOTICE AND HOLD THE HEARING IN ACCORDANCE WITH TITLE 10, SUBTITLE 2 OF THE STATE GOVERNMENT ARTICLE.

(C) OATHS.

THE SUPERINTENDENT MAY ADMINISTER OATHS IN CONNECTION WITH ANY PROCEEDING UNDER THIS SECTION.

(D) SPECIFIC NOTICE REQUIREMENTS.

THE HEARING NOTICE TO BE GIVEN TO THE INDIVIDUAL SHALL BE WRITTEN AND SENT AT LEAST 10 DAYS BEFORE THE HEARING.

(E) RIGHT TO COUNSEL.

THE INDIVIDUAL MAY BE REPRESENTED AT THE HEARING BY COUNSEL.

589. SAME -- SURRENDER OF SECURITY GUARD CERTIFICATION CARD.

WITHIN 5 DAYS AFTER A SECURITY GUARD'S CERTIFICATION IS SUSPENDED OR REVOKED, THE INDIVIDUAL SHALL SURRENDER TO THE SUPERINTENDENT THE INDIVIDUAL'S CERTIFICATION CARD.

590. SAME -- JUDICIAL REVIEW.

ANY INDIVIDUAL WHOSE APPLICATION FOR CERTIFICATION AS A SECURITY GUARD HAS BEEN DENIED UNDER § 586 OF THIS SUBTITLE OR WHOSE CERTIFICATION AS A SECURITY GUARD HAS BEEN SUSPENDED OR REVOKED UNDER § 586 OF THIS SUBTITLE MAY TAKE AN APPEAL AS ALLOWED IN §§ 10-215 AND 10-216 OF THE STATE GOVERNMENT ARTICLE.

PART VI. MISCELLANEOUS PROVISIONS.

591. AGENCY RESPONSIBLE FOR ACTS OF EMPLOYEES.

A PRIVATE DETECTIVE AGENCY IS RESPONSIBLE FOR THE ACTS OF EACH OF ITS EMPLOYEES WHILE THE EMPLOYEE IS CONDUCTING THE BUSINESS OF THE AGENCY.

592. SUPERVISION OF OFFICES.

(A) IN GENERAL.

THE OFFICES OF A PRIVATE DETECTIVE AGENCY SHALL BE SUPERVISED BY AN INDIVIDUAL WHO:
