[(h)] (M) (1) "Contractor" means [any] A person having a contract with a State agency.

(2) "Contractor" does not include [employees with labor contracts] AN EMPLOYEE WITH AN EMPLOYMENT CONTRACT OR AN EMPLOYEE ORGANIZATION WITH A COLLECTIVE BARGAINING AGREEMENT.

(N) "COST REIMBURSEMENT CONTRACT" MEANS A CONTRACT UNDER WHICH THE STATE REIMBURSES THE CONTRACTOR FOR THOSE CONTRACT COSTS, WITHIN A STATED CEILING, WHICH ARE RECOGNIZED AS ALLOWABLE AND ALLOCABLE UNDER THE COST AND PRICE PRINCIPLE REGULATIONS ADOPTED IN ACCORDANCE WITH § 11-128 OF THIS SUBTITLE, AND WHICH MAY INCLUDE A FEE.

(O) (1) "CONTROL" MEANS THE POWER TO SUPERVISE, REGULATE, AND COMMAND.

(2) "CONTROL" INCLUDES THE AUTHORITY TO APPROVE OR DISAPPROVE AN ACTION.

[(i)] (P) "Department" means the [Departments] STATE TREASURER, THE DEPARTMENT of General Services, THE DEPARTMENT OF Transportation, THE DEPARTMENT OF Budget and Fiscal Planning, [and] OR the University of Maryland.

(Q) (1) "ENGINEERING SERVICES" MEANS PROFESSIONAL OR CREATIVE WORK THAT IS PERFORMED IN CONNECTION WITH UTILITIES, STRUCTURES, BUILDINGS, MACHINES, EQUIPMENT, AND PROCESSES AND THAT REQUIRES ENGINEERING EDUCATION, TRAINING, AND EXPERIENCE IN THE APPLICATION OF SPECIAL KNOWLEDGE OF THE MATHEMATICAL, PHYSICAL, AND ENGINEERING SCIENCES.

(2) "ENGINEERING SERVICES" INCLUDES CONSULTATION, INVESTIGATION, EVALUATION, PLANNING, DESIGN, AND SUPERVISION OF CONSTRUCTION--FOR--THE--PURPOSE--OF--INTERPRETING--AND--ASSURING COMPLIANCE--WITH--SPECIFICATIONS--AND--DESIGN--

(R) "ESTABLISHED CATALOG PRICE" MEANS THE PRICE INCLUDED IN THE MOST CURRENT CATALOG, PRICE LIST, SCHEDULE, OR OTHER FORM THAT:

(1) IS REGULARLY MAINTAINED BY THE MANUFACTURER OR SUPPLIER OF AN ITEM;

(2) IS PUBLISHED OR AVAILABLE FOR INSPECTION BY CUSTOMERS; AND
