- (1) ESTABLISH policies and procedures GOVERNING PROCUREMENT for University College overseas programs [that promote]; AND
- (2) PROMOTE the purposes [set forth] STATED in § [11-201(b)] 11-102 of this [article] SUBTITLE.
- [(e)] (D) A procurement agency shall give notice in the Maryland Register of each contract, contract extension or contract renewal costing more than \$25,000 it enters into with an entity listed in subsection (b)(l) by which it procures human, social, or educational services for third party clients described in § [13-207(a)] 11-115 of this [article] SUBTITLE.
- (E) THE BOARD MAY EXEMPT-FROM MODIFY OR WAIVE THE REQUIREMENTS OF THIS SUBTITLE AND FROM SUBTITLE 2 OF THIS TITLE, AS TO A PROCUREMENT FOR A CONTRACT OR A CLASS OF CONTRACTS THAT ARE TO BE PERFORMED ENTIRELY OUTSIDE THE UNITED STATES TO THE EXTENT:
- (1) THE BASIC PURPOSES STATED IN \$ 11-102 OF THIS SUBTITLE ARE MAINTAINED;
- (2) THE CIRCUMSTANCES OF THE PROCUREMENT REQUIRE THE MODIFICATION OR WAIVER; AND
- (3) FOREIGN CONTRACTORS ARE EXPECTED TO BE INVOLVED IN THE PROCUREMENT.
 - (F) (1) THIS SUBTITLE DOES NOT APPLY TO PROCUREMENT BY:
 - (I) BLIND INDUSTRIES AND SERVICES OF MARYLAND;
- (II) MARYLAND STATE ARTS COUNCIL FOR THE PROMOTION OR SUPPORT OF THE ARTS; AND
- (III) MARYLAND STATE PLANNING COUNCIL ON DEVELOPMENTAL DISABILITIES FOR SERVICES TO SUPPORT DEMONSTRATION, PILOT, AND TRAINING PROGRAMS:-;
- (IV) THE MARYLAND AUTOMOBILE INSURANCE FUND FOR SUPPLIES-AND SERVICES RELATED TO ITS CLAIMS OPERATIONS, FOR REINSURANCE, AND FOR SERVICES RELATED TO ITS INVESTMENT AND BANKING ACTIVITIES:
- (V) THE MARYLAND ENVIRONMENTAL SERVICE WHEN ENGAGED IN ENTERPRISE ACTIVITIES FINANCED EXCLUSIVELY ON A USER CHARGE OR CONTRACT BASIS WITH NONSTATE FUNDS:
- (VI) THE MARYLAND HEALTH AND HIGHER EDUCATIONAL FACILITIES AUTHORITY TO THE EXTENT THAT NO MONEYS OF THE STATE ARE TO BE EXPENDED ON A CONTRACT;
- (VII) THE MARYLAND HISTORICAL TRUST FOR THE PURPOSE OF SURVEYING AND EVALUATING
