- (III) THE BOARD SHALL ENSURE THAT THE REGULATIONS OF THE PROCUREMENT DEPARTMENTS PROVIDE FOR PROCEDURES THAT ARE CONSISTENT WITH THIS SUBTITUE DIVISION 11 AND, TO THE EXTENT THE CIRCUMSTANCES OF A PARTICULAR TYPE OF PROCUREMENT OR A PARTICULAR STATE AGENCY DO NOT REQUIRE OTHERWISE, ARE SUBSTANTIALLY THE SAME.
- (2) THE BOARD MAY DELEGATE ANY OF ITS AUTHORITY AND MAY REQUIRE PRIOR BOARD APPROVAL FOR SPECIFIED PROCUREMENT ACTIONS.
- (3) EXCEPT AS LIMITED BY THE STATE CONSTITUTION, THE BOARD MAY EXERCISE ANY CONTROL AUTHORITY CONFERRED ON A DEPARTMENT BY THIS SUBTITUE DIVISION 11, AND TO THE EXTENT THAT ITS ACTION CONFLICTS WITH THE ACTION OF THE DEPARTMENT, THE ACTION OF THE BOARD SHALL PREVAIL.
- (C) (1) NOTWITHSTANDING ANY GENERAL DELEGATION PURSUANT TO SUBSECTION (B) OF THIS SECTION, THE BOARD RETAINS FULL AUTHORITY TO PROCURE SERVICES AND SUPPLIES FOR ITSELF UNLESS THAT AUTHORITY IS SPECIFICALLY DELEGATED TO ANOTHER ENTITY.
- (2) BY RESOLUTION, THE BOARD MAY AUTHORIZE ANY BOARD MEMBER OR ANY STATE AGENCY TO EXERCISE ALL OR ANY PART OF THIS AUTHORITY FOR A SPECIFIC BOARD PROCUREMENT OR A PARTICULAR CLASS OF BOARD PROCUREMENTS.
- (D) SUBJECT TO THIS SUBTITUE <u>D1V1SION 11</u> AND THE AUTHORITY OF THE BOARD SET FORTH IN SUBSECTION (B) OF THIS SECTION, JURISDICTION OVER PROCUREMENTS IS AS FOLLOWS:
- (1) STATE TREASURER: AUTHORITY TO PROCURE AND TO CONTROL PROCUREMENT OF INSURANCE AND BANKING AND FINANCIAL SERVICES, AS PROVIDED BY DIVISION I OF THIS ARTICLE AND § 3 OF ARTICLE VI OF THE CONSTITUTION;
- (2) DEPARTMENT OF BUDGET AND FISCAL PLANNING: AUTHORITY TO CONTROL:
- (I) PROCUREMENT OF INFORMATION PROCESSING EQUIPMENT AND ASSOCIATED SERVICES, AS PROVIDED BY TITLE 3, SUBTITLE 4 OF THIS ARTICLE;
- (II) PROCUREMENT OF SERVICES BY STATE AGENCIES EXCEPT AS OTHERWISE EXPRESSLY INDICATED BY THIS SUBTITLE; AND
- (III) LEASES AND RENTALS OF AUTOMOBILES, AS PROVIDED IN TITLE 3, SUBTITLE 5 OF THIS ARTICLE;
- (3) DEPARTMENT OF GENERAL SERVICES: AUTHORITY TO PROCURE AND TO CONTROL PROCUREMENT OF:
- (I) LEASES OF REAL PROPERTY, INCLUDING LEASES COVERED BY TITLE 4, SUBTITLE 3 OF THIS ARTICLE:
