- (II) SUPPLIES, INCLUDING SUPPLIES COVERED BY TITLE 4, SUBTITLE 3 OF THIS ARTICLE, BUT EXCLUDING INSURANCE, INFORMATION PROCESSING EQUIPMENT, AND AUTOMOBILE LEASES;
- (III) CONSTRUCTION, INCLUDING CONSTRUCTION COVERED BY TITLE 4, SUBTITLE 4 OF THIS ARTICLE;
- (IV) CONSTRUCTION RELATED SERVICES, INCLUDING THOSE COVERED BY TITLE 4, SUBTITLE 4 OF THIS ARTICLE; AND
- (V) ARCHITECTURAL AND ENGINEERING SERVICES, AS PROVIDED BY PART XV OF THIS SUBTITLE;
- (4) DEPARTMENT OF TRANSPORTATION AND THE MARYLAND TRANSPORTATION AUTHORITY: AUTHORITY TO PROCURE, WITHOUT THE APPROVAL OF ANY OTHER DEPARTMENT:
- (I) TRANSPORTATION RELATED CONSTRUCTION, AS PROVIDED BY THE TRANSPORTATION ARTICLE OF THE CODE;
- (II) TRANSPORTATION RELATED CONSTRUCTION RELATED SERVICES, AS PROVIDED BY THE TRANSPORTATION ARTICLE OF THE CODE;
- (III) TRANSPORTATION RELATED ARCHITECTURAL AND ENGINEERING SERVICES, AS PROVIDED BY PART XIV OF THIS SUBTITLE; AND
- (IV) ROLLING STOCK AND OTHER PROPERTY PECULIAR TO THE OPERATION OF A TRANSIT SYSTEM AS PROVIDED BY § 7-403 OF THE TRANSPORTATION ARTICLE OF THE CODE;
- (5) UNIVERSITY OF MARYLAND: AUTHORITY TO PROCURE, WITHOUT THE APPROVAL OF ANY OTHER DEPARTMENT:
- (I) SUPPLIES FOR THE UNIVERSITY, INCLUDING AUTOMOBILES, BUT EXCLUDING SUPPLIES FUNDED BY STATE GENERAL OBLIGATION BOND PROCEEDS AND INSURANCE, AND INCLUDING INFORMATION PROCESSING SUPPLIES ONLY TO THE EXTENT PROVIDED BY TITLE 3, SUBTITLE 4 OF THIS ARTICLE;
- (II) SERVICES FOR THE UNIVERSITY, BUT EXCLUDING BANKING AND FINANCIAL SERVICES UNDER THE AUTHORITY OF THE TREASURER AS PROVIDED IN PARAGRAPH (1) OF THIS SUBSECTION, AND INCLUDING INFORMATION PROCESSING SERVICES ONLY TO THE EXTENT PROVIDED BY TITLE 3, SUBTITLE 4 OF THIS ARTICLE;
- (III) CONSTRUCTION AND CONSTRUCTION RELATED SERVICES FOR THE UNIVERSITY, REGARDLESS OF THE SOURCE OF FUNDS, TO THE EXTENT THAT AUTHORITY OVER SPECIFIC PROJECTS OR CLASSES OF PROJECTS IS GRANTED BY THE BOARD; AND
- (IV) LEASES OF REAL PROPERTY IF THE LEASE PAYMENTS ARE NOT PAID FROM THE GENERAL FUND.
