- A CRIME VICTIM OR WITNESS HAS-THE-FOLLOWING-BASIC-RIGHTS-SHOULD:
- (1) TO BE INFORMED BY APPROPRIATE CRIMINAL JUSTICE AGENCIES OF THIS-BIBB-OF-RIGHTS. THESE GUIDELINES;
- (2) θ BE TREATED WITH DIGNITY, RESPECT, COURTESY, AND SENSITIVITY- τ -;
- (3) TO RECEIVE CRISIS INTERVENTION ASSISTANCE, IF NEEDED, OR TO BE INFORMED BY THE APPROPRIATE CRIMINAL JUSTICE AGENCY WHERE CRISIS INTERVENTION ASSISTANCE, EMERGENCY MEDICAL TREATMENT, CREDITOR INTERCESSION SERVICES, OR OTHER SOCIAL SERVICES AND COUNSELING MAY BE OBTAINED-T-;

- (5) TO BE ADVISED OF THE PROTECTION AVAILABLE, AND ON REQUEST TO BE PROTECTED BY CRIMINAL JUSTICE AGENCIES, TO THE EXTENT REASONABLE, PRACTICABLE, AND, IN THE AGENCY'S DISCRETION, NECESSARY, FROM HARM OR THREATS OF HARM ARISING OUT OF THE CRIME VICTIM'S OR WITNESS'S COOPERATION WITH LAW ENFORCEMENT AND PROSECUTION EFFORTS---;
- (6) DURING ANY PHASE OF THE INVESTIGATIVE PROCEEDINGS OR COURT PROCEEDINGS, TO BE PROVIDED, TO THE EXTENT PRACTICABLE, A WAITING AREA THAT IS SEPARATE FROM A SUSPECT AND THE FAMILY AND FRIENDS OF A SUSPECT-:-;

- (8) TO BE ADVISED OF AND, ON REQUEST, TO BE PROVIDED WITH EMPLOYER INTERCESSION SERVICES, WHEN APPROPRIATE, BY THE STATE'S ATTORNEY'S OFFICE OR OTHER AVAILABLE RESOURCE TO SEEK EMPLOYER COOPERATION IN MINIMIZING AN EMPLOYEE'S LOSS OF PAY OR OTHER BENEFITS RESULTING FROM PARTICIPATION IN THE CRIMINAL JUSTICE PROCESS---;
