

RIGHT-OF-WAY LINE OF SOUTH CENTRAL AVENUE TO A POINT OF INTERSECTION WITH THE NORTHERN RIGHT-OF-WAY LINE OF FLEET STREET; THENCE RUNNING IN A WESTERLY DIRECTION AND BINDING ON THE NORTHERN RIGHT-OF-WAY LINE OF FLEET STREET TO A POINT OF INTERSECTION WITH THE WESTERN RIGHT-OF-WAY LINE OF SOUTH EXETER STREET; THENCE RUNNING IN A NORTHERLY DIRECTION AND BINDING ON THE WESTERN RIGHT-OF-WAY LINE OF SOUTH EXETER STREET TO A POINT OF INTERSECTION WITH AN EXTENDED NORTHERN LOT LINE OF 1200 BANK STREET; THENCE RUNNING IN AN EASTERLY DIRECTION AND CROSSING EXETER STREET, AND BINDING ON THE NORTHERN LOT LINE OF 1200 BANK STREET AND THE NORTHERN LOT LINE OF 1206 BANK STREET TO A POINT OF INTERSECTION WITH WESTERN LOT LINE OF 302 SOUTH CENTRAL AVENUE; THENCE RUNNING IN A NORTHERLY DIRECTION AND BINDING ON THE WESTERN LOT LINE OF 302 SOUTH CENTRAL AVENUE TO A POINT OF INTERSECTION WITH THE SOUTHERN RIGHT-OF-WAY LINE OF FAWN STREET; THENCE RUNNING IN AN EASTERLY DIRECTION AND BINDING ON THE SOUTHERN RIGHT-OF-WAY LINE OF FAWN STREET TO A POINT OF INTERSECTION WITH THE EXTENDED WESTERN LOT LINE OF 1022-1024 FAWN STREET; THENCE CROSSING FAWN STREET AND BINDING ON SAID EXTENDED LINE AND THE WESTERN LOT LINE OF 1022-1024 FAWN STREET; TO A POINT OF INTERSECTION WITH THE SOUTHERN RIGHT-OF-WAY LINE OF GOUGH STREET; THENCE RUNNING IN A WESTERLY DIRECTION AND BINDING ON THE SOUTHERN RIGHT-OF-WAY LINE OF GOUGH STREET TO A POINT OF INTERSECTION WITH THE WESTERN RIGHT-OF-WAY LINE OF LLOYD STREET; THENCE RUNNING IN A NORTHERLY DIRECTION AND BINDING ON THE WESTERN RIGHT-OF-WAY LINE OF LLOYD STREET TO A POINT OF INTERSECTION WITH THE SOUTHERN RIGHT-OF-WAY LINE OF EAST PRATT STREET TO A POINT OF INTERSECTION WITH AN EXTENDED WESTERN LOT OF 1142-1154 EAST PRATT STREET; THENCE RUNNING IN A NORTHERLY DIRECTION AND BINDING ON THE WESTERN LOT LINE OF 1142-1154 EAST PRATT STREET TO A POINT OF INTERSECTION WITH THE NORTHERN RIGHT-OF-WAY LINE OF GRAMBY STREET; THENCE RUNNING IN A WESTERLY DIRECTION AND BINDING ON THE NORTHERLY RIGHT-OF-WAY LINE OF GRAMBY STREET TO A POINT OF INTERSECTION WITH THE WESTERN LOT LINE OF 1046 GRAMBY STREET TO A POINT OF INTERSECTION WITH THE SOUTHERN LOT LINE OF 1123 EAST LOMBARD STREET; THENCE RUNNING IN A MORE OR LESS WESTERLY DIRECTION AND BINDING ON THE IRREGULAR LINE FORMED BY THE REAR OF THE PROPERTIES 1001-1123 EAST LOMBARD STREET TO A POINT OF INTERSECTION WITH THE EASTERN RIGHT-OF-WAY LINE OF SOUTH EXETER STREET; THENCE RUNNING IN A SOUTHERLY DIRECTION AND BINDING ON THE EASTERN RIGHT-OF-WAY LINE OF SOUTH EXETER STREET TO A POINT OF INTERSECTION WITH AN EXTENDED SOUTHERN LOT LINE OF 100 SOUTH EXETER STREET; THENCE RUNNING IN A WESTERLY DIRECTION CROSSING SOUTH EXETER STREET ALONG SAID EXTENDED LINE AND BINDING ON THE SOUTHERN LOT LINE OF 100 SOUTH EXETER STREET TO A POINT OF INTERSECTION WITH THE WESTERN LOT LINE OF 100 SOUTH EXETER STREET TO A POINT OF INTERSECTION WITH THE NORTHERN RIGHT-OF-WAY LINE OF EAST LOMBARD STREET; THENCE RUNNING IN AN EASTERLY DIRECTION AND BINDING ON THE NORTH RIGHT-OF-WAY LINE OF EAST LOMBARD STREET TO A POINT OF INTERSECTION WITH THE WESTERN RIGHT-OF-WAY LINE OF SOUTH EXETER STREET; THENCE RUNNING IN A NORTHERLY DIRECTION AND BINDING ON THE WESTERN RIGHT-OF-WAY LINE OF SOUTH EXETER STREET TO A POINT OF INTERSECTION WITH THE SOUTHERN RIGHT-OF-WAY LINE OF EAST BALTIMORE STREET; THENCE RUNNING IN A WESTERLY DIRECTION TO A POINT OF INTERSECTION WITH THE EXTENDED WESTERN RIGHT-OF-WAY LINE
