- (A) THERE IS AN INTERAGENCY CHILD CARE bicensing COUNCIL.
- (B) THE INTERAGENCY CHILD CARE LICENSING COUNCIL IS A PART OF THE DEPARTMENT OF HUMAN RESOURCES FOR BUDGETARY AND ADMINISTRATIVE PURPOSES ONLY.

9-1303.

- (A) THE COUNCIL SHALL CONSIST OF:
- (1) THE SECRETARY OF THE DEPARTMENT OF HEALTH AND MENTAL HYGIENE OR A DESIGNEE OF THE SECRETARY;
- (2) THE SECRETARY OF THE DEPARTMENT OF HUMAN RESOURCES OR A DESIGNEE OF THE SECRETARY;
