- (E) "OCCUPYING AGENCY" MEANS A STATE AGENCY OR DEPARTMENT WHICH IS OR WILL BE LOCATED IN A STATE-OWNED STATE-OCCUPIED BUILDING.
- (F) "STATE---OWNED STATE-OWNED STATE-OCCUPIED BUILDING" MEANS:
- (1) AN OFFICE BUILDING ACQUIRED THROUGH ANY MEANS BY THE STATE FOR USE BY A STATE AGENCY OR DEPARTMENT; AND
- (2) AN OFFICE BUILDING CONSTRUCTED BY OR FOR THE STATE FOR OCCUPANCY BY A STATE AGENCY OR DEPARTMENT.
- (A) THE DEPARTMENT MAY ESTABLISH GROUP DAY CARE CENTERS FOR THE CHILDREN OF STATE EMPLOYEES IN STATE-OWNED STATE-OCCUPIED BUILDINGS IN THE MANNER PROVIDED IN THIS SECTION.
- (B) BEFORE THE STATE ACQUIRES OR CONSTRUCTS AN OFFICE BUILDING THAT ACCOMMODATES 700 OR MORE EMPLOYEES, THE DEPARTMENT OF GENERAL-SERVICES HEALTH AND MENTAL HYGIENE SHALL:
- (1) SURVEY THE EMPLOYEES WHO WILL BE ASSIGNED TO THE BUILDING REGARDING THE EMPLOYEES' CHILD CARE NEEDS;
- (2) DETERMINE WHETHER CHILD CARE SERVICES FOR MORE THAN 29 CHILDREN ARE NEEDED; AND
- (3)--IP--SUPFICIENT--NEED--IS--DEMONSTRATED,-DESIGNATE SPACE-WITHIN-THE-BUILDING-FOR-A-GROUP-DAY-CARE-CENTER.
- MUCH SPACE IS REQUIRED AND REQUEST THAT THE DEPARTMENT OF GENERAL SERVICES DESIGNATE THE REQUIRED AMOUNT OF SPACE WITHIN THE BUILDING OR ACQUIRE THE DESIGNATED AMOUNT OF SPACE WITHIN A NEARBY BUILDING FOR A GROUP DAY CARE CENTER.
- (C) THE OCCUPYING AGENCY SHALL NOTIFY THE EMPLOYEE OCCUPANTS OF THE AVAILABILITY OF SPACE FOR A GROUP DAY CARE CENTER AT LEAST 180 DAYS BEFORE THE PROJECTED DATE OF OCCUPANCY.
- (A) THE DEPARTMENT OF HUMAN RESOURCES AND THE DEPARTMENT OF GENERAL SERVICES SHALL COOPERATE WITH AND ASSIST THE DEPARTMENT IN CARRYING OUT THE PURPOSES OF THIS PART II OF THIS SUBTITLE.
