- (2) CONDUCTED FOR AT LEAST 7 DAYS DURING A 3 WEEK PERIOD.
- (E) "bigense <u>CERTIFICATE</u>" MEANS A SINGLE bigense <u>CERTIFICATE</u> ISSUED BY A-STATE-OR-LOCAL-HEALTH-OFFICER THE DEPARTMENT TO A YOUTH CAMP UNDER THIS SUBTITLE.
- (F) "OPERATE" MEANS TO SUPERVISE, CONTROL, CONDUCT, OR MANAGE A YOUTH CAMP AS:
 - (1) AN OWNER;
 - (2) AN AGENT OF THE OWNER;
 - (3) A LESSEE OF THE OWNER;
 - (4) A DIRECTOR; OR
 - (5) AN INDEPENDENT CONTRACTOR.
 - (G) "RESIDENTIAL CAMP" MEANS A YOUTH CAMP OPERATING AT A FACILITY OR CAMPSITE AT WHICH A CAMPER EITHER LIVES APART OR INTENDS TO LIVE APART FROM THE CAMPER'S RELATIVES, PARENTS, OR LEGAL GUARDIANS FOR AT LEAST 7 CONSECUTIVE 24-HOUR DAYS.
 - (H) "TRAVEL CAMP" MEANS A CAMP THAT:
 - (1) OPERATES FOR NOT LESS THAN 24 HOURS A DAY FOR AT LEAST 7 CONSECUTIVE DAYS; AND
 - (2) PROVIDES FOR CAMPERS TO USE MOTORIZED TRANSPORTATION TO MOVE AS A GROUP TO OR AMONG SITES FOR EXPERIENCES IN DIFFERENT ENVIRONMENTS.
 - (I) "TRIP CAMP" MEANS A CAMP:
 - (1) THAT OPERATES FOR NOT LESS THAN 24 HOURS A DAY FOR AT LEAST 7 CONSECUTIVE DAYS; AND
 - (2) IN WHICH A GROUP OF INDIVIDUALS MOVE FROM 1 SITE TO ANOTHER UNDER THEIR OWN POWER OR BY TRANSPORTATION WHICH PERMITS INDIVIDUAL GUIDANCE OF A VEHICLE OR ANIMAL.
 - (J) "YOUTH CAMP" OR "CAMP" MEANS ANY DAY CAMP, RESIDENTIAL CAMP, TRAVEL CAMP, OR TRIP CAMP THAT:
 - (1) ACCOMMODATES 7 OR MORE CAMPERS WHO ARE UNRELATED TO THE PERSON OPERATING THE CAMP:
 - (2) PROVIDES PRIMARILY OUTDOOR RECREATIONAL ACTIVITIES:
 - (3) HAS PERMANENT BUILDINGS, TEMPORARY BUILDINGS, OR NO BUILDINGS; OR
