(5)--IF--BY--MAY--15--A--FINANCIALLY--RESPONSIBLE--COUNTY--FAILS--TO--MAKE--THE--REQUIRED--PAYMENT--TO--A--SERVICE--PROVIDING--LOCAL--EDUCATION--AGENCY,--THE--STATE--SUPERINTENDENT--SHALL--DEDUCT--FROM--THE--NEXT--PAYMENT--OF--STATE--AID--TO--THE--FINANCIALLY--RESPONSIBLE--COUNTY--AN--AMOUNT--EQUAL--TO--THE--AMOUNT--OWED--UNDER--THIS--PARAGRAPH--AND--SHALL--PAY--THOSE--FUNDS--TO--THE--SERVICE--PROVIDING--LOCAL--EDUCATION--AGENCY.

(7)--THE--STATE--BOARD--MAY--ADOPT--REGULATIONS--WHICH--IMPLEMENT--THIS--SECTION.

(3)-(1)--"CHILD---IN---AN---OUT-OF-COUNTY---LIVING ARRANGEMENT" MEANS A CHILD WHO IS PLACED IN A FOSTER CARE HOME OR RESIDENTIAL FACILITY:

1.---IN---A---COUNTY---IN---THE---STATE---OTHER---THAN WHERE---THE---CHILD'S---PARENT---OR---LEGAL---GUARDIAN---RESIDES---;---AND

2.---BY---A---STATE---AGENCY,---BY---A---LICENSED---CHILD PLACEMENT---AGENCY---PROVIDED---FOR---UNDER---§---5---507---OF---THE---FAMILY---LAW ARTICLE,---OR---BY---A---COURT.

(11)--"CHILD---IN---AN---OUT-OF-COUNTY---LIVING ARRANGEMENT" DOES NOT INCLUDE A CHILD LIVING WITH A RELATIVE, STEPPARENT,--OR--A--PERSON--EXERCISING--TEMPORARY--CARE,--CUSTODY,--OR--CONTROL--OVER--A--CHILD--AT--THE--REQUEST--OF--A--PARENT--OR--GUARDIAN--OF--THE--CHILD.

(4)--"SERVICE--PROVIDING--LOCAL--EDUCATION--AGENCY" MEANS THE--EDUCATION--AGENCY--FOR--THE--COUNTY--IN--THE--STATE--WHERE--A--CHILD--IN--AN--OUT--OF--COUNTY--LIVING--ARRANGEMENT--IS--PLACED.

(5)--"HOME--COUNTY" MEANS--THE--COUNTY--IN--THE--STATE--WHERE--A--PARENT--OR--LEGAL--GUARDIAN--OR--LEGAL--CUSTODIAN--OF--A--CHILD--IN--AN--OUT--OF--COUNTY--LIVING--ARRANGEMENT--RESIDES.

(B)--THE--SERVICE--PROVIDING--LOCAL--EDUCATION--AGENCY--SHALL--ARRANGE--FOR--AN--APPROPRIATE--EDUCATION--FOR--A--CHILD--WHO--IS--PLACED--IN--AN--OUT--OF--COUNTY--LIVING--ARRANGEMENT--IN--THE--COUNTY.
