- [(2) On the fifth Monday preceding any election, the local board shall accept registration by mail applications until the board office closes.]

- B. THE UNITED STATES POSTAL SERVICE, OR THE POSTAL SERVICE OF ANY OTHER COUNTRY, HAS PROVIDED VERIFICATION OF THAT FACT BY AFFIXING A MARK SO INDICATING ON THE COVERING ENVELOPE; AND
- ON THE FOURTH WEDNESDAY PRECEDING THE ELECTION INVOLVED.
- ESTABLISHED IN SUBSECTION (A)(1) OF THIS SECTION SHALL BE ACCEPTED, BUT THE REGISTRATION OF THE APPLICANT MAY NOT BECOME EFFECTIVE UNTIL THE REGISTRATION RECORDS ARE NEXT OPEN PURSUANT TO SUBSECTION (A) OF THIS SECTION.
