(A) WITH THE APPROVAL OF THE GOVERNOR, THE DIRECTOR MAY APPOINT A DEPUTY DIRECTOR.

(B) (1) THE DEPUTY DIRECTOR SERVES AT THE PLEASURE OF THE DIRECTOR.

(2) THE DEPUTY DIRECTOR IS ENTITLED TO THE ~~SALARIES~~ SALARY PROVIDED IN THE STATE BUDGET.

(3) THE DEPUTY DIRECTOR HAS THE DUTIES PROVIDED BY LAW OR DELEGATED BY THE DIRECTOR.

(C) (1) THE DIRECTOR MAY EMPLOY A STAFF AND RETAIN CONSULTANTS IN ACCORDANCE WITH THE STATE BUDGET.

(2) UNLESS OTHERWISE PROVIDED BY LAW AND EXCEPT AS PROVIDED IN PARAGRAPH (4) OF THIS SUBSECTION, THE DIRECTOR SHALL APPOINT AND REMOVE ALL OTHER STAFF IN ACCORDANCE WITH THE PROVISIONS OF THE STATE MERIT SYSTEM LAW.

(3) THE APPOINTMENT OR REMOVAL OF STAFF OF ANY UNIT IN THE AGENCY IS SUBJECT TO THE APPROVAL OF THE DIRECTOR. AS TO ANY UNIT IN THE AGENCY, THE DIRECTOR MAY DELEGATE THIS AUTHORITY TO THE HEAD OF THAT UNIT.

(4) ALL PERSONNEL IN THE AGENCY SPECIFIED IN THIS PARAGRAPH SHALL BE EXEMPT FROM THE STATE MERIT SYSTEM AND SHALL BE APPOINTED BY, AND SERVE AT THE PLEASURE OF THE DIRECTOR:

(I) ANY ASSISTANT DIRECTOR;

(II) ANY DIRECTOR OF AN INSTITUTION; AND

(III) THE SUPERINTENDENT OF THE YOUTH CENTERS.

(5) ALL PERSONNEL IN THE AGENCY WHO ARE SUBJECT TO THE PROVISIONS OF PARAGRAPH (4) OF THIS SUBSECTION SHALL BE PROHIBITED FROM OTHER EMPLOYMENT WHILE EMPLOYED BY THE AGENCY, UNLESS EXPRESS PERMISSION IS GRANTED BY THE DIRECTOR. EXPRESS
