(ii) Except for instant bingo, in Baltimore County, bingo is governed by § 252 of this article.

(iii) In Baltimore County, notwithstanding any regulations to the contrary, instant bingo need not be offered in conjunction with other customary bingo games.

(4) (i) In Baltimore County, any organization which operates a carnival, bazaar, or raffle under this section shall first obtain a permit which provides that [such] THE carnival, bazaar, or raffle shall be managed AND-OPERATED personally only by the members of the organization and the permit shall not be transferable.
