

(IV) -- CARD GAMES OF ANY SORT ARE -- PROHIBITED -- AT THE CARNIVAL, BAZAAR, OR RAFFLE.

(V) -- ANY -- BET -- OR -- WAGER -- PERMITTED -- UNDER -- THIS SECTION -- MAY NOT EXCEED \$10. -- THIS SUBPARAGRAPH DOES NOT APPLY TO THE SALE OF A RAFFLE TICKET.

(VI) -- ALCOHOLIC BEVERAGES MAY NOT BE CONSUMED ON OR ABOUT THE PREMISES IN WHICH A CARNIVAL, BAZAAR, OR RAFFLE IS CONDUCTED, -- UNLESS THE ORGANIZATION HAS OBTAINED A LICENSE ISSUED BY THE BALTIMORE COUNTY BOARD OF LICENSE COMMISSIONERS.

(VII) -- AN INDIVIDUAL UNDER THE AGE OF -- 21 -- YEARS MAY NOT BE PERMITTED TO PLAY, PARTICIPATE IN, CONDUCT, OR OPERATE ANY GAME OR GAMING DEVICE FOR WHICH A PERMIT IS ISSUED UNDER THIS SUBSECTION.

(VIII) -- AN ORGANIZATION MAY NOT OBTAIN MORE THAN 12 PERMITS DURING A 12 MONTH PERIOD.

(IX) -- A -- GAMING -- ACTIVITY AT A CARNIVAL, BAZAAR, OR RAFFLE HELD -- UNDER -- THIS -- SUBSECTION -- MAY -- BE -- CONDUCTED -- ONLY BETWEEN THE HOURS OF 4 P.M. AND 2 A.M.

(X) -- AN -- ORGANIZATION -- WHICH -- IS -- ISSUED A PERMIT UNDER THIS SECTION SHALL WITHIN -- 30 -- DAYS -- AFTER -- EACH -- CARNIVAL, BAZAAR, -- OR -- RAFFLE -- SUBMIT -- TO -- THE -- DEPARTMENT -- OF -- PERMITS AND LICENSES ON A FORM PRESCRIBED AND PROVIDED BY THE DEPARTMENT:

1. -- AN ACCOUNTING OF ALL FUNDS RECEIVED OR PLEDGED;

2. -- AN ACCOUNTING OF ALL EXPENSES PAID -- OR INCURRED;

3. -- A -- STATEMENT -- UNDER OATH OF THE AMOUNT AND APPLICATION OF THE NET PROFITS DERIVED; AND

4. -- NAMES, -- ADDRESSES, -- AND -- AGES -- OF -- ALL INDIVIDUALS -- WHO -- OPERATED -- OR -- MANAGED -- ANY -- GAMING -- DEVICES -- OR ACTIVITIES AT THE CARNIVAL, BAZAAR, OR RAFFLE.

(XI) -- THE DEPARTMENT -- OF -- PERMITS -- AND -- LICENSES SHALL -- ESTABLISH -- PROCEDURES FOR REGULATING AND MONITORING GAMING ACTIVITIES AUTHORIZED BY THIS SECTION.

(5) IN BALTIMORE COUNTY, NOTWITHSTANDING THE PROVISIONS OF SUBSECTION (B) OF THIS SECTION:

(I) CARD GAMES, DICE GAMES, AND ROULETTE, AND ANY EVENTS COMMONLY KNOWN AS CASINO NIGHTS, ARE PROHIBITED;
