(A) EXCEPT AS PROVIDED UNDER SUBSECTION (B) OF THIS SECTION, ANY PROVISION IN AN AGREEMENT BETWEEN A SAVINGS AND LOAN ASSOCIATION AND A HOLDER OF AN ACCOUNT IN THE ASSOCIATION THAT PROVIDES FOR A PERIOD OF TIME LONGER THAN THE TIME PRESCRIBED UNDER THIS SECTION SHALL BE CONSIDERED UNREASONABLE AND THE MAXIMUM PERIOD OF TIME PERMITTED BY REGULATION SHALL APPLY.
