9-241. RECORDS MAINTAINED BY DEPARTMENT.

TO ALLOW THE PUBLIC TO IDENTIFY EVERY PERMIT THAT THE DEPARTMENT ISSUES FOR A PARTICULAR TRACT OF LAND, THE DEPARTMENT SHALL MAINTAIN A PERMANENT PUBLIC RECORD OF ALL SEWAGE SLUDGE UTILIZATION PERMITS ISSUED UNDER § 9-236 OF THIS SUBTITLE.

9-242. PERMIT HOLDER TO KEEP RECORDS AND FURNISH INFORMATION.

THE DEPARTMENT SHALL REQUIRE EACH HOLDER OF A SEWAGE SLUDGE UTILIZATION PERMIT TO:

(1) KEEP ~~DAI~~LY RECORDS, INCLUDING DAILY RECORDS OF THE SOURCE AND AMOUNT OF SEWAGE SLUDGE FOR EACH TRUCKLOAD DELIVERED TO THE SITE;

(2) MAKE REPORTS, INCLUDING REPORTS OF SEWAGE SLUDGE ANALYSIS, AS OFTEN AS NECESSARY TO ASSURE THAT THE SEWAGE SLUDGE MEETS PERMIT REQUIREMENTS;

(3) INSTALL, CALIBRATE, USE, AND MAINTAIN MONITORING EQUIPMENT OR METHODS; INCLUDING BIOLOGICAL MONITORING METHODS AND ~~MONITORING-WELLS~~ WELL MONITORING, IF APPROPRIATE;

(4) TAKE SAMPLES IN ACCORDANCE WITH THE METHODS, AT THE LOCATIONS, AT THE INTERVALS, AND IN THE MANNER THAT THE DEPARTMENT REQUIRES; AND

(5) GIVE TO A REPRESENTATIVE OF THE DEPARTMENT OR THE LOCAL HEALTH OFFICIAL ANY INFORMATION THAT THE DEPARTMENT REASONABLY REQUIRES.
