- (2) "LAW ENFORCEMENT AGENCY" INCLUDES: -
- (I) A STATE, COUNTY, OR MUNICIPAL POLICE DEPARTMENT OR AGENCY;
 - (II) A SHERIFF'S OFFICE:
 - (III) A STATE'S ATTORNEY'S OFFICE: AND
 - (IV) THE ATTORNEY GENERAL'S OFFICE.
- (L) "LOCAL DEPARTMENT" MEANS THE DEPARTMENT OF SOCIAL SERVICES THAT HAS JURISDICTION IN THE COUNTY:
- (1) WHERE THE ALLEGEDLY ABUSED OR NEGLECTED CHILD LIVES; OR
- (2) IF DIFFERENT, WHERE THE ABUSE OR NEGLECT IS ALLEGED TO HAVE TAKEN PLACE.
- (M) "LOCAL STATE'S ATTORNEY" MEANS THE STATE'S ATTORNEY FOR THE COUNTY:
- (1) WHERE THE ALLEGEDLY ABUSED OR NEGLECTED CHILD LIVES: OR
- (2) IF DIFFERENT, WHERE THE ABUSE OR NEGLECT IS ALLEGED TO HAVE TAKEN PLACE.
- "NEGLECT" MEANS THE SUSTAINING BY A CHILD OF SIGNIFICANT PHYSICAL OR MENTAL HARM OR INJURY FROM:
- (1) THE ABSENCE OF THE CHILD'S PARENTS, GUARDIAN, CUSTODIAN; OR
- (2) THE FAILURE OF THE CHILD'S PARENTS, GUARDIAN, OR CUSTODIAN TO GIVE PROPER CARE AND ATTENTION TO THE CHILD AND THE CHILD'S PROBLEMS UNDER CIRCUMSTANCES THAT INDICATE THAT THE CHILD'S HEALTH OR WELFARE IS HARMED OR THREATENED THEREBY, UNLESS THE FAILURE CONSISTS ONLY OF PROVIDING THE CHILD WITH NONMEDICAL REMEDIAL CARE AND TREATMENT RECOGNIZED BY STATE LAW INSTEAD OF MEDICAL TREATMENT.
- (O) "PEDOPHILIA" MEANS A CONDITION IN WHICH A PERSON'S CONSCIOUS SEXUAL DESIRES AND RESPONSES ARE DIRECTED, EITHER PARTIALLY OR EXCLUSIVELY, TO CHILDREN.
- $hinspace{\{\Theta\}}$ (P) "POLICE OFFICER" MEANS ANY STATE OR LOCAL OFFICER WHO IS AUTHORIZED TO MAKE ARRESTS AS PART OF THE OFFICER'S OFFICIAL DUTY.
- (P) (Q) (1) "SEXUAL ABUSE" MEANS ANY ACT THAT INVOLVES SEXUAL MOLESTATION OR EXPLOITATION OF A CHILD BY A PARENT OR
