- (1) PASSES THE DEPARTMENTALLY PRESCRIBED COURSE IN BOATING SAFETY EDUCATION-; OR
- (11) PASSES A BOATING SAFETY EQUIVALENCY EXAMINATION ADMINISTERED BY PERSONS AUTHORIZED TO OFFER THE COURSE ON BOATING SAFETY EDUCATION.
- (2) UPON REQUEST, THE DEPARTMENT SHALL PROVIDE, WITHOUT CHARGE, BOATING SAFETY EDUCATION MATERIALS TO PERSONS WHO PLAN TO TAKE THE BOATING SAFETY EQUIVALENCY EXAMINATION.
- (2) (3) (1) ONCE ISSUED, THE CERTIFICATE BOATING EDUCATION IS VALID FOR THE LIFETIME OF THE PERSON TO WHOM IT WAS ISSUED AND MAY NOT BE REVOKED BY THE DEPARTMENT OR A COURT OF LAW.
- THE DEPARTMENT SHALL REPLACE. (II)WITHOUT CHARGE, A LOST OF DESTROYED CERTIFICATE IF THE DEPARTMENT ISSUED THE CERTIFICATE OR HAS A RECORD THAT THE CERTIFICATE WAS BY THE U.S. COAST GUARD OR THE U.S. POWER SQUADRON.
- (4) (1) THE DEPARTMENT OR ITS DESIGNEE MAY ISSUE A 30-DAY TEMPORARY CERTIFICATE OF BOATING SAFETY EDUCATION PERSON WHO SIGNS AN AFFIDAVIT STATING THAT THE PERSON HAS READ AND UNDERSTOOD THE BOATING SAFETY EDUCATION MATERIALS PROVIDED BY THE DEPARTMENT.
- (II)THE 30-DAY TEMPORARY CERTIFICATE BOATING SAFETY EDUCATION ISSUED IN ACCORDANCE WITH PARAGRAPH (4)(1) OF THIS SUBSECTION MAY BE RENEWED FOR ONE ADDITIONAL 30-DAY PERIOD.
- (4) (5) IN LIEU OF A CERTIFICATE OF BOATING SAFETY EDUCATION ISSUED BY THE DEPARTMENT, A LICENSE ISSUED BY THE U.S. COAST GUARD, OR A BOATING SAFETY CERTIFICATE ISSUED BY A UNIT OF THE U.S. COAST GUARD AUXILIARY, THE U.S. POWER SQUADRON, OR Α LOCAL BOARD OF EDUCATION, IS SUFFICIENT TO COMPLY WITH THE REQUIREMENTS OF THIS SECTION.
- (2) (5) (6) IN LIEU OF A CERTIFICATE OF BOATING SAFETY EDUCATION ISSUED BY THE DEPARTMENT, A BOATING SAFETY CERTIFICATE ISSUED IN ANOTHER STATE IN ACCORDANCE WITH CRITERIA THE NATIONAL ASSOCIATION OF STATE BOATING LAW ADMINISTRATORS IS SUFFICIENT TO COMPLY WITH THE REQUIREMENTS OF THIS SECTION.
